**Sub : - Direction regarding procedure to be a Registered Graduate**

Whereas, Maharashtra Public Universities Act, 2016 (hereinafter referred as the Act) came into force w.e.f 1<sup>st</sup> March 2017.

And

Whereas, the provisions for becoming Registered Graduates are provided u/s 131 of the Act.

And

Whereas, the Government of Maharashtra in the light of provisions made u/s 72(10) of the Act has prescribed the uniform Statute No. 2 of 2017 in respect of Form of application for registration of graduates and payment of fees.

And

Whereas, the fees for becoming a registered graduate is to be determined by the University, subject to maximum of Rs. 20 (Rs. Twenty only) .

And

Whereas, the procedure regarding submission of such forms through online or offline mode by the University is not prescribed in the said statute and also the form for enrolling in electoral roll of Registered Graduates under sub section (5) of section 131 of the said Act is not prescribed in the said statute.

And

Whereas, it is necessary to prescribe fees, procedure of registration of Registered Graduates through online or offline mode and to prescribe form for enrolling in electoral roll of registered graduates by statute in the light of subject matter mentioned u/s 71 (13) of the Act.

And

Whereas, Direction No. 5/2017 dt. 1.6.2017 in this regard, was used for the last election i.e. authorities elections-2017, which was converted into draft Statute No. 1/2021 and submitted to the Honøble Chancellor's office vide letter No. SGBAU/21/LegalCell/192/2021, dt. 5.5.2021 as approved by the Management Council and the Senate. The consent to the said draft Statute, from the Honøble Chancellor is yet to received.

And

Whereas, taking into consideration of the proviso of sub-section (8) of section 12 of the Act, it needs to issue again the same Direction for authorities elections-2022.

Now , therefore I, Dr.Dileep N. Malkhede, Vice-Chancellor of the Sant Gadge Baba Amravati University in exercise of powers conferred upon me u/s 12(8) of the Maharashtra Public Universities Act 2016, issues the following direction : -

1. This direction may be called as Procedure to be a Registered Graduates Direction, 2022
2. This direction shall come into force from the date of its issuance.
3. Form for Registration of Graduates and form of Application for Enrolling as Voter in the Electoral Roll of Register Graduates are made online basis only.
4. The fee for registration of Graduates is Rs. 20/- (Rs. Twenty only).
5. Appendix- A is a Form of application for enrolling as voter in the electoral roll of Registered Graduates as appended with this direction.
