Subject :- Discontinuation of Moderation of answer-books during process of assessment of answer-books of University Examinations.

Whereas, the process of moderation of answer-books during assessment is provided since 2001- 2002 - session vide Ordinance No.19 of 2001 and consequently reflected in Ordinance No.21 of 2001 and Ordinance No.16 of 2007.

AND

Whereas, the Board of Examinations in its meeting held on 14/02/2008 vide item No.17 considering that the facility of providing photocopy of answer-books has been extended to the desirous examinees who can apply for redressal of grievance, on which basis the re-assessment of answer-books is done by the University. Therefore, the process of moderation of answer-books during assessment period itself, has become an additional activity, due to which more time is required in process of declaration of examination results, hence the process of moderation be discontinued.

AND

Whereas, the Academic Council has accepted the above recommendations of Board of Examinations and recommended to the Management Council vide item No.63, in its meeting held on 30.04.2008.

AND

Whereas, the Management Council vide item No.268, in its meeting held on 10.07.2008 has accepted the recommendations of the Academic Council referred to above to discontinue the system of moderation of answer-books.

AND

Whereas, the matter is required to be regulated by an Ordinance by amending the concerning Ordinance No.19 of 2001 and correlated Ordinance No. 21 of 2001 and Ordinance No.16 of 2007.

AND

Whereas, the procedure of amending an Ordinances is to be done as per provisions of Maharashtra Universities Act,1994, which is time taking process and the matter is to be implemented early before commencement of Winter-2008 examinations.

Now, therefore, I, Dr. Kamal Singh, Vice-Chancellor, Sant Gadge Baba Amravati University, in exercise of powers conferred upon me, under sub-section (8) of Section 14 of Maharashtra Universities Act, 1994, hereby issue the direction as under:-

1. This direction may be called “ Discontinuation of Moderation of answer-books during process of assessment of answer-books of University examinations.”
2. This Direction shall come into force w.e.f. Winter-2008 examinations.
3. **(I) In Ordinance No. 19/2001 :-**
 - i) In the heading of the Ordinance, the word, “and moderation” be deleted.
 - ii) In Para-I, and Para-5. I (c) (iv) the words, “and moderation” be deleted. Likewise in the said para in Clause (vii) the words, “Moderators” be deleted.

- iii) In Para-5(E) and in clause (i) & (ii) the word “Moderation” be deleted. In the said para-5(E) in Clause (ii) the words appearing in 3rd line, “or moderators, but the names of moderators shall not be included in the panels of examiners of that particular paper. However, the names of moderators may be included in the panels of examiners of another paper.” be deleted.
- (iv) In para-5.I (E) :- The Clause (iv) and (v) be completely deleted. Consequently the clauses numbering from (vi) to (xiii) be renumbered as (iv) to (xi) respectively.
- In renumbered clause (iv) the word, “moderators” be deleted.
 - In renumbered clause (v) the words, “and moderation to be done simultaneously” be deleted.
 - In renumbered clauses (vi),(vii),(viii),(ix), the word “moderators”be deleted wherever its appears.
 - In renumbered clause (x) the words,”& moderation” be deleted.
 - In renumbered clause (xi), in 1st line the words, “and moderators” and in 2nd line the word “moderation” be deleted.
- (v) In para-5.I (H), in 1st line the word “moderation” be deleted.
- (vi) In para-5.II, in the heading, the words, “AND MODERATION” be deleted.
- (vii) The sub-para (C) and (D) of para-5. II, be completely deleted.
- (viii) In para-5.III(A), the clause (i) be substituted as under:-
- “(i) The answer-books shall be unmasked as per the procedure after assessment by the examiner.”
 - (ix) In Appendix-A, of the Ordinance, in Sr.No.3, the words, “and moderation” be deleted.

(II) In Ordinance No. 21 of 2001 :—

- (i) In heading of the ordinance, in the citation, and in para-1 of the ordinance, the word, “Moderators/” be deleted.
- (ii) In Part-”A” in Sr. No. 1,2,3,4,5,the word, “Moderators” be deleted wherever it appears. Likewise in Sr.No.06, the words, “and moderators”be deleted. Also in Sr.No.07, the word, “moderators” be deleted.
- (iii) In Part-”D”, Sr.No.04, be completely deleted. Consequently, the Sr.No.”5,6 & 7,” be renumbered as “4,5, & 6” respectively.

(III) In Ordinance No. 16 of 2007 :-

- (i) In Part-I, In Para-8, the words “moderator/s” be deleted.
- (ii) In Part-II : In Para-14, the word “moderator” and the word “moderated” be deleted.
- (iii) In Para-16, the word “moderator” be deleted.
- (iv) In para-25, the words “or moderator/s” be deleted.
