*ITEM NO. 2 CO-OPTION OF THE HEAD OF THE DEPARTMENT FROM AN AFFILIATED COLLEGE HAVING POST-GRADUATE TEACHING IN THE SUBJECT

To co-opt Head of the Department who is recognized for imparting teaching to post graduate students in an affiliated colleges or a recognized institution having post graduate teaching in that subject as provided under proviso of clause (a) of sub-section (2) of section 40 of the Maharashtra Public Universities Act, 2016.

(Notes:

- 1. Provision of clause (a) of sub-section (2) of section 40 of the Maharashtra Public Universities Act, 2016, is as follows:
 - (a) "head of the university department or institution in the relevant subject:

Provided that, where there is no university department in the subject, the Board shall, at its first meeting co-opt the head of department who is recognized for imparting teaching to post graduate students in an an affiliated college or a recognized institution having post-graduate teaching in that subject;"

- 2. Head to be co-opted under section 40 (2) (a) of M.P.U.Act, 2016 shall satisfy the following eligibility conditions as per Direction No. 26/2023, dated 27.4.2023.
 - (i) Head of the Department who is recognized for imparting teaching to post-graduate students in an affiliated college or a recognized institution having post-graduate teaching in that subject,
 - (ii) Shall possess Ph.D. Degree, unless he is a Principal appointed as a Principal before 13th October, 2000,
 - (iii) Shall have at least ten years teaching experience at undergraduate level in aggregate,
 - (iv) Shall have undertaken university examination related work for at least five years in aggregate.
- 3. The procedure of the Co-option shall be as prescribed by Direction No. 26/2023, dated 27.4.2023.
- 4. Copy of the proforma of nomination paper for (Appendix C-1) co-option of the Head of Department from an affiliated college/recognised institution having post graduate teaching in that subject is circulated vide Direction No. 26/2023 in Book No. 1 of 2023.

 - Provided that, any person who was the member of the Management Council of the university or chairman of the Board of Studies, for the first time whether as elected, nominated or co-opted member, as the case may be, on the date of commencement of this Act, shall not be deemed to have enjoyed the consecutive term if he is nominated or elected or co-opted for the first time after the commencement of this Act."
- 3. As per Higher and Technical Education Department, Govt. of Maharashtra's Notification No. MNS-2016/(347/16)/Ue-3, dated 28th April, 2017 the eligibility conditions for chairperson of Board of Studies are as under:
 - "(a) Shall possess Ph.D. Degree,
 - (b) Shall have at least fifteen years teaching experience in aggregate,
 - (c) Shall be a post graduate recognised teacher imparting teaching to post graduate students,
 - (d) Shall be a recognised Ph.D. Guide under whose supervision, at least two students have been awarded Ph.D. Degree,

- (e) Shall have authored/co-authored at least two text books/reference books or shall have published at least three research papers in peer reviewed journals as first/corresponding author,
- (f) Shall have undertaken university examination related work for at least five years in aggregate.
- 4. The Candidate will enclose the Certificates/Undertakings attested by competent/related Authority with Nomination form.
- 5. Procedure to be adopted at the meeting for Election of the Chairperson of the Board shall be as laid down under Direction No. 24/2023, dated 27.4.2023.
- 6. The working chairperson/ presiding officer shall scrutinizes the nomination papers along with attested documents/Certificates attached to it by the candidate.

ITEM NO. 5 NOMINATION OF TWO MEMBERS OF THE BOARD ON THE COMMITTEE PROVIDED UNDER SECTION 48(3)(a)(iv) OF THE MAHARASHTRA PUBLIC UNIVERSITIES ACT, 2016

To nominate two members of the Board of Studies from amongst its members of whom at least one shall be a Post Graduate teacher to constitute Committees for every subject as provided under section 48(3)(a)(iv) of the Maharashtra Public Universities Act, 2016.

 - (b) The Committee shall prepare lists of persons for various examinations and tests, included in the panels to be prepared by the Board of Studies and shall submit them to the Pro- Vice-Chancellor, who shall submit the same with his recommendations. if any, to the Board of Examinations and Evaluation, which shall then appoint paper-setters, examiners and moderators, and where necessary referees.
 - (c) No member of the Board of Examinations and Evaluation or the committees constituted under this section shall be appointed as a paper- setter, examiner, moderator or referee:

 Provided that, the Pro- Vice- Chancellor shall have power to appoint a member of the Board of Examinations and Evaluation or the committees constituted under this section, as a paper-setter, examiner, moderator or referee where no teacher relating to such subject who is not a member of the Board of Examinations and Evaluation or the committees is available. "
 - If more members are interested for nomination on committee than the vacant post prescribed by the Act under section 48(3)(a)(iv) the nomination form, notice of withdrawal and ballot paper—etc. will be decided by Chairperson/Working Chairperson with related changes in appendices and procedure mentioned in Direction related to Nomination of one person on faculty.
