महाराष्ट्र सार्वजनिक विद्यापीठ अधिनियम, २०१६ च्या कलम ३०(४)(च),(छ),(ज),(झ) मधील तरतुदी अन्वये व्यवस्थापन परिषदेवर अनुक्रमे प्रतिनिधीत्व करणारे दोन प्राचार्य, दोन अध्यापक, दोन व्यवस्थापन प्रतिनिधी व दोन नोंदणीकृत पदवीधर यापैकी एक अनुसूचित जाती किंवा अनुसूचित जमाती किंवा निरधिसूचित जमाती (विमुक्त जाती) / भटक्या जमाती किंवा इतर मागासवर्गाची व्यक्ती असेल. महाराष्ट्र शासनाने निर्गमित केलेल्या अध्यादेश क्र. २८/२०१७ (पुन्हा नव्याने निर्गमित केलेला अध्यादेश क्र. १/२०१८) अन्वये सदरहू अधिनियमाच्या कलम ३०(४) ला परंतुका जोडून दुरुस्ती केली आहे. सदरहू दुरुस्तीनुसार प्रत्येक वर्गवारीसाठीचा आरक्षणाचा प्रारंभिक क्रम हा चिठ्ठ्या टाकून काढलेल्या सोडतीद्वारे ठरवावयाचा अधिकार मा.कुलगुरुंना प्रदान केला आहे.

याकरिता मा.कुलगुरुंनी महाराष्ट्र सार्वजनिक विद्यापीठ अधिनियम, २०१६ चे कलम १२(८) अंतर्गत निदेश क्र. २/२०१८, दिनांक १८.१.२०१८ मध्ये सोडतीची कार्यरिती विहित केली असून सदर निदेश यासोबत माहितीकरीता जोडला आहे.

महाराष्ट्र सार्वजनिक विद्यापीठ अधिनियम, २०१६ च्या कलम ३०(४) ला दुरुस्ती करणा-या परंतुकानुसार आरक्षणाचा क्रम ठरविण्यासाठी सोडतीद्वारे ठरविण्याकरिता सदरहू निदेश क्र. २/२०१८ नुसार दिलेल्या कार्यरितीद्वारे पार पाडण्यास्तव मा. कुलगुरुंनी सोमवार, दिनांक २९ जानेवारी, २०१८ रोजी दुपारी १.०० वाजताची वेळ निश्चित केलेली आहे.

Subject : Procedure to be adopted while drawing of lots for representation of reserved categories on Management Council Direction, 2018.

Whereas, the Maharashtra Public Universities Act, 2016 (hereinafter referred as the 'Act') come into force w.e.f. 1st March, 2017;

And

Whereas, the Higher & Technical Education Department, Mumbai has amended the Act vide Ordinance No. XXVIII of 2017 dt. 28th November, 2017;

And

Whereas, under the said Ordinance, the following proviso has been added after the sub-section (4) of section 30 of the Act -

“Provided that, for the election of the candidate from the reserved categories, under clauses (f), (g), (h) and (i), for the initial term of Management Council, immediately after the commencement of this Act, point of rotation for reserved categories under the said clauses shall be decided by drawing of lots by Vice-Chancellor, and while drawing of lots, it shall be ensured that the person belonging to each reserved category shall have representation on the Management Council.”

And

Whereas, the order of category wise reservation proposed in the said clauses are as under -

“Scheduled Castes or Scheduled Tribes or De-notified Tribes (*Vimukta Jatis*) or Nomadic Tribes or Other Backward Class”

And

Whereas, the procedure for drawing lots having representation to each reserved category on the Management Council is to be prescribed;

Now, therefore, I, Dr. Murlidhar G. Chandekar, Vice-Chancellor, of the Sant Gadge Baba Amravati University in exercise of powers conferred upon me u/s 12(8) of the Act, issue the following direction :-

1. This Direction may be called **“Procedure to be adopted while drawing of lots for representation of reserved categories on Management Council Direction, 2018.”**
2. This Direction shall come into force w.e.f. the date of its issuance.
3. Procedure for drawing lots –
 - a) The Registrar, in consultation with Vice-Chancellor, shall fix the date and time for declaration of allotment of category wise reservation for the election of the candidate from the reserved categories under clauses (f), (g), (h) and (i) for the initial term of the Management Council.

Provided firstly that, category wise reservation to be continued from the said initial term for the respective clauses.

Provided secondly that, a period for a particular category in any case shall not be transferable to any other category. It should be treated as ‘vacant’ for the said period, if the suitable candidate from the concerned category is not available.
 - b) The Registrar shall give wide publicity to the said programme through the official website of the University.
 - c) On the date fixed for this, the Registrar shall put two separate bowls. One bowl shall contain lots regarding names of the constituencies and other bowl shall contain lots regarding names the categories.
 - d) The Registrar, before requesting the Vice-Chancellor to draw lots one by one from both bowls at a time, shall make announcement before the audience present in the hall regarding actual procedure of drawing the lots. After drawing the lots, it should be declared by the Registrar.
