Sub: Deceptive Bahai Conversions - Inroads towards Indian Universities

Respected Sir.

It is an honour to write to you. Sir, I address this letter to you as Chancellor of all Universities of the State of Maharashtra.

In this letter, I wish to bring to your kind attention the penetration of Bahai clandestine network into Indian Universities. Sir, through a remote location in interiors of Maharashtra called Panchgani (a small hill-station), the Bahais have set-up 'Bahai Academy'. This so called academy conducts several propagandist activities discreetly through conducting courses on unassuming subjects:

- 1. Moral Values
- 2. Human Capacity Building
- 3. Youth Moral Development
- 4. Ethical Conduct

These courses are based on Bahai principles and silently project other cultures and religious practices and customs as outdated, primitive, orthodox, unscientific, non-progressive and gender-biased while the Religion of Modern Era (read 'Bahai Faith') as keeping with the times, modern, scientific, progressive and having solutions for mankind in modern times. While these things are not directly conveyed, they are induced into the one going through these courses. Towards the end, as a Bahai trainer takes one through these well-designed courses, one gets a feeling of necessity of change in what an individual had always been following, towards a 'modern way of thinking'.

Sir, the Bahai Academy is attempting to project itself as a non-government research institute committed towards uplifting the moral standards and potential of the youth and society. Through this 'noble mission' it has established contacts with major universities at Pune, Kolhapur, Mumbai and Indore. It conducts courses regularly for trainers of these subjects at universities at its scenic premises at Panchgani. Needless to say, the gullible participants get more than impressed at the hospitality offered and return with an attitude of strong inclination towards the Bahai Faith. The Universities on their part are happy that one of their responsibilities is being shared by the Bah'ai Academy.

While apparently the activities are seen as act of service, the aims are far more sinister. It attempts at targeting:

 The academicians – as the Bahai Faith needs the educated elite in its public relations and propagation activities.

2. The tutors – as the Bahi Faith needs the well versed having access to college and university youth.

. The students – as the Bahai Faith is interested in getting young new members to add to their present numbers and sees them as investment sure to multiply as the youth set-up families in future.

Sir, I have had the misfortune of being associated with the Bahai Faith for a few years before wisdom prevailed. To summarize my conclusions after deep study of the Bahai Faith, I would like to list following:

- Foundation of the Bahai Faith was laid by Imperialists in Iran through 'spiritual stooges' like Syed Ali Mohammed Shirazi (alias Bab) and Mirza Hussain Noori (the Bahai prophet, akka Bahaullah).
- The early Bahai 'messiahs' were clearly identified as spies by the government of their times in Iran, Iraq and Turkey. These characters ultimately were harnessed by Britain in the present day Israel.

3. Advise all ministers of GOM to avoid celebrations hosted by Bahais.

 Pass the message to other state governments to be on alert for Bahai activities. The states should in-turn pass the message upto district and taluka level.

Bahai trustees accused of embezzling funds

NAZIYA Alvi New Delhi, July 13

IN A complaint filed in a city court, a few trustees of the National Spiritual Assembly of Bahais of India have been accused of espionage by their colleagues. Apparently, they were supplying classified documents from India's defence establishments to Israeli and Iranian spying agencies and making huge amounts in foreign currency.

Taking cognisance of the complaint, the additional chief metropolitan magistrate, Kamini Lau, has directed the Economic Offence Wing Cell to immediately register a case against the accused persons. The court has also asked the cell to file a status report with it by August 10.

As per the allegations in the complaint, one of the accused, N.K. Bhudhiraja, general manager of finance with the spiritual organisation, forged an identity card and af-

fixed his photograph on an armed forces concessions form for fee baggage allowance, which is needed for military officials travelling to places in India and abroad. Apparently, he also used to travel under the fictitious name of 'Captain S. Budhiraja' of the air force station at Yelahanka.

Apparently, the accused, by using such impersonations and forgery managed to clandestinely penetrate into the prohibited defence establishment of the country and get hold of classified documents. In turn, he supplied the sensitive documents to spying agencies in Israel and Iran in return of foreign currency.

The complaint has also alleged that the stamp of the air

force station at Yelahanka had been forged with some amount of accuracy and was being used by the accused trustees of the 'spiritual assembly'.

The complaint also alleges that another accused, Payam Shoghi, also a trustee with the society, is in truth an Iranian national. He fraudulently got his name inserted in the ration card of another accused and also got it attested.

On the basis of the ration card he managed to procure an Indian passport. The complaint also states that such passports have been issued to a number of other foreigners by the accused people through a similar fashion of forgery.

The counsel of three complainants Swadesh Kumar, Khub Singh and Gulshan Kumar told the court that they have definitive documentary evidence to prove that the accused were, in addition to the other violations, involved in a large scale Hawala transaction network.
