Subject: Declaration of election of Shri M.R.Pawar to the Management Council of the

University u/s 27(1)(j) of the M.U.Act, 1994.

Ref'nce: Notification No. 15/2011, dt. 21.2.2011

Whereas, the election to the Management Council of the University under section 27(1)(j) of the Maharashtra Universities Act, 1994 (hereinafter referred as the Act) was held on 15.2.2011. For which two Principals were to be elected on the Management Council from the Senate from amongst the Principals who are members of the Senate. Out of these two seats, one seat was allotted to DT/NT category by rotation;

AND

Whereas, Dr.A.S.Rathod had submitted the Nomination Form for contesting election for the seat of the reserved category (DT/NT) on the Management Council under section 27(1)(j) of the Act;

AND

Whereas, the Registrar & Returning Officer, after the decision of the Scrutiny Committee and satisfying himself, rejected the Nomination Form of Dr.A.S.Rathod on the ground that he has submitted the Nomination for reserved category (DT/NT), whereas he was elected on the Senate from general category;

AND

Whereas, Dr.A.S.Rathod had made appeal to the Vice-Chancellor & the appellate authority of the University against the decision of the Registrar & Returning Officer;

AND

Whereas, the Vice-Chancellor & the appellate authority of the University upheld the decision of the Registrar & Returning Officer for election and gave the following rulling on the appeals of Dr.A.S.Rathod & Dr.S.G.Motke -

"The Nomination Forms of Dr.A.S.Rathod, Principal, 8, Mahalaxmi Colony, Shankar Nagar, Amravati and Dr.S.G.Motke, Principal, Phulsing Naik Mahavidyalaya, Pusad are rejected for contesting the election to the Management Council as per provision of section 27(1)(j) in the category of one principal from the DT/NT category as they are not elected from DT/NT category on the Senate u/s 25(2)(l) of the M.U.Act, 1994";

AND

Whereas, the University had declared Shri M.R.Pawar as elected unopposed to the Management Council from DT/NT category;

AND

Whereas, Dr.A.S.Rathod had filed petition before the Hon'ble Chancellor of the University, u/s 108 of the Act, for deciding the validity of election of Shri M.R.Pawar as a member to the Management Council of the Sant Gadge Baba Amravati University u/s 27(1)(j) of the Act and by setting aside the decision of the appellate authority to reject the nomination of petitioner;

AND

Whereas, the Chancellor of the University has passed the order No. CS/AU/37/11/(7298)/1113, dt. 1st April, 2013 in respect of the petition filed by Dr.A.S.Rathod and communicated to the University vide letter No. CS/AU/37/11/(7298)/1114, dt. 2nd April,2013 that -

"hereby set aside the decision of the Registrar & Returning Officer and the Vice-Chancellor and the appellate authority to reject the nomination of Dr.Rathod for contesting election to the Management Council and consequently declare the election of Shri M.R.Pawar to the Management Council of the university u/s 27(1)(j) of the Act, as void ab-initio."

Now, it is hereby declared that the election of Shri M.R.Pawar, Principal, Gulam Nabi Azad Arts, Commerce & Science College, Barshi Takali, Dist. Akola, to the Management Council of the University u/s 27(1)(j) of the Act, as void ab-initio and also hereby notified for information of all concerned that the membership acquired by Shri M.R.Pawar, on the Management Council u/s 27(1)(j) of the Act is invalid in accordance with the order passed by Hon'ble Chancellor.

By virtue of his membership on the Management Council, membership acquired by him on the other authorities/bodies/committees of the university shall also stands invalid.
