STATUTE NO. 1 OF 2015

A Statute further to amend the Statute regarding Rules of procedure at the meeting of the University Senate (Amendment) Statute, 2015.

Whereas, it is expedient further to amend the Statute regarding "Rules of procedure at the meeting of the University Senate" (i.e. Original Statute No. 45) for the purposes hereinafter appearing, the Senate is hereby pleased to pass the following Statute:-

- 1. This Statute may be called "Rules of procedure at the meeting of the University Senate (Amendment) Statute, 2015.
- 2. This Statute shall come into force with effect from the date of Chancellor's assent to it.
- 3. After clause (e) of first proviso of sub para (1) of para 36 of the Statute regarding Rules of procedure at the meeting of the University Senate i.e. Original Statute No. 45 (hereinafter referred to as the main Statute), the following clauses be added -
 - "(f) it shall be based on the matter within the period of last preceding two years of the year of meeting of the Senate only.
 - (g) it shall not contain the matter which is already regulated by Act/Statute/Ordinance/Regulation/Rule/Direction of the University.
 - (h) it shall not contain ambiguity.
 - (i) it shall not contain the matter which is subjudice."
- 4. After sub para (2) of para 36 of the main Statute, the following sub paras be added -
 - "(3) On announcement of the name of the member, he shall choose one of the questions which, in his opinion is most important in public interest, for supplementary question.
 - (4) For interpellation, the question hour shall be of one hour.
 - (5) On completion of one question each, opportunity shall be given to the member for asking second question in chronological manner, if time remains. The House shall decide the extension of time of interpellations, if member putting questions do not get opportunity for asking at least one question within stipulated time."
