- This Direction shall come into force with effect from the sessions as underi)Academic Session 2015-2016 for B.Ed. Semester I & II ii)Academic Session 2016-2017 for B.Ed. Semester III & IV

3) Eligibility for Admission:

(a)A candidate should have passed the Bachelor's Degree/Master Degree in Sciences, Social Sciences/Humanities/Commerce of Sant Gadge Baba Amravati University or of any other university recognised by University Grants Commission (UGC) with at least marks decided by the State of Maharashtra and NCTE time to time.

OR

- (b)Bachelor in Engineering or Technology with specialization in Science and Mathematics of any recognised university with at least marks decided by the state of Maharashtra and NCTE time to time. S/he should have offered at least one school subject at the first and/or second degree level as principal or subsidiary or allied or optional subject. (School subject means the subject included in the syllabus of Secondary/Higher secondary level in the Maharashtra State).
- (c)The reservation and relaxation of 5 % marks will be given to the candidates belonging to S.C./ S.T. / V.J.N.T./ OBC/PWD/SBC and other notified categories as per the Maharashtra State Government Rules.

4. Admission Procedure:

Admission to the eligible candidates shall be made on merit on the basis of marks obtained in the qualifying examination and/or in the entrance examination or as per the selection procedure laid down by the State Government of Maharashtra and Sant Gadge Baba Amravati University from time to time.

5. **Medium of Instruction:** Medium of Instruction at the B.Ed. course will be English or Marathi, or Hindi

6. Medium of Answer:

The candidate appearing for the B .Ed. examination will have the option of answering all papers either in Marathi, English or Hindi. This option can be exercised course wise and not section wise or question wise. The medium of answering the paper for course in 'Pedagogy of school subjects' (language course) will be in the concerned language only.

7. Duration and Intake:

The B.Ed. programme shall be of two years duration that is four semesters which can be completed in a maximum of three years from the date of admission to the programme. 9. Working Days:

10 Attendance:

Every candidate must have minimum 80% attendance in theory courses and sessional Work and 90% attendance in field attachment. 11. Examination Fees:

12. Scheme of Evaluation:

- **A)** For theory paper examination; there will be 30 % internal marks (sessional work) and 70 % of marks for examination conducted by university.
- **B)** 70% marks for University examination means theory paper.
- C) 30% marks for internal assessment (sessional work) of core courses by the University Department/College assessment for sessional/practicum work, etc. mentioned in syllabus.
- **D)** The institution shall have to preserve the record of the internal/sessional work submitted by each student for consecutive three calendar years from the date of his/her admission in the B Ed course
- **E)** The Final lesson and its Viva-voce examination will have both internal and external examiner.
- F) The marks will be converted in grades and credits and finally CGPA.
- **G)** To pass the examination a candidate must obtain at least 50% of marks in practical/internal and 40% of marks in university examination (Theory Papers) of each course/heads separately in all four semesters and aggregate of 50% marks in all.
- **H)** A maximum of three years from the date of admission to the programme is allowed for programme completion.

J) The marks of each semester examination for the B. Ed. Course (Theory and Sessional Work) will be converted into grades.

13. Pattern of Question Paper:

There are four theory papers having weightage of 70 marks and eleven theory papers having weightage of 35 marks.

- A) For question paper of 70 marks:
 - i. The syllabus has been divided into five units. There will be five questions.
 - ii. Two questions shall be of long answer type question and three questions shall be of short answer type question and shall have equal weightage.
- iii. For every long answer or short answer question there will be alternative choice from the same unit. However there will be no internal choice in a question.
- iv. Division of marks between long answer and short answer type question will be in the ratio of 40 and 60.
- v. The duration of theory paper of 70 marks shall be of 3 hours.
- B) For question paper of 35 marks:
- i. The syllabus has been divided into three units. There will be three questions.
- ii. One question shall be of long answer type question and two questions shall be of short answer type question and shall have equal weightage.
- iii. For every long answer or short answer question there will be alternative choice from the same unit. However there will be no internal choice in a question.

- iv. Division of marks between long answer and short answer type question will be in the ratio of 40 nd 60.
- v. The duration of theory paper of 35 marks shall be of 2 hours.

14. Grading System:

After adding the internal marks (maximum 30%) to external marks (maximum 70%), the marks secured by a student from maximum 100 will be converted into a letter grade. The grade points are the numerical equivalent of letter grade assigned to a student in the ten points scale as given below,

15. Calculation of Semester Grade Point Average (SGPA):

- a. Performance in a semester will be expressed as Semester Grade Point Average (SGPA).
- b. Cumulative performance of all the semesters together will reflect performance in the whole programme and it will be known as Cumulative Grade Point Average (CGPA). Thus CGPA is the real indicators of a student's performance.
- c. The formula for calculation of SGPA and CGPA is given below:

Where

C_i - number of credits for the ith course,

G_{ni} - grade points of the ith course of the nth semester

Computation of SGPA and CGPA:

The UGC recommends the following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

i. The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e

SGPA (Si) =

(C_i x G_i) / Σ C_i

Where, Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

ii. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

where Si is the SGPA of the ith semester and Ci is the total number of credits in that semester.

- iii. The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.
- iv. The final Class for B.Ed. Degree shall be awarded on the basis of CGPA.

16. Award of Degree:

The degree shall be awarded to the students on the basis of CGPA (Cumulative Grade Point Average) of the four semesters' performance in the exams.

- b) Reservation and relaxation for SC/ST/VJNT/PWD/SBC and other applicable categories will be as per the rules of the Maharashtra State Government.
- c) A candidate admitted to M. Ed course should not do any other course during the same academic year.
- **4. ADMISSION PROCEDURE:** Admission in M.Ed., shall be made as per Maharashtra Govt. and University rules and regulation.
- 5. **DURATION AND INTAKE:** The M.Ed. programme shall be of two years duration that is four semesters which can be completed in a maximum of three years from the date of admission to the programme. An examinee who does not pass or fail to present himself/herself at the M.Ed. course first semester to fourth semester examination in six consecutive examinations inclusive of the first shall not be allowed to continue the M.Ed. course. It includes field attachment of a minimum of four weeks and a research dissertation.
- **6. WORKING DAYS:** The institution shall work for minimum of thirty six hours in a week during which faculty and students concerned with the conduct of the programme shall be available for interaction, dialogue, consultation and mentoring students.
- 7. ATTENDANCE: Every candidate must have minimum 80% attendance in theory courses and practicum and 90% attendance in field attachment. Every candidate should have to complete all the practical work to the satisfaction of the Head/Principal. He / She should have obtained such certificate from the Head/Principal of the institute and the copy of the same to be submitted to the University by the institution on the behalf of examinees.
- **8. MEDIUM OF INSTRUCTION:** The medium of instruction shall be English or Marathi or Hindi. The candidate appearing for the M.Ed. examination will have the option of answering all papers eitherin English, Hindi or in Marathi.
- **9. EXAMINATION FEES:** As per the Sant Gadge Baba Amravati University/ Maharashtra Govt. Rules.

10.SCHEME OF EVALUATION

- a) The theory examination will have 25 % internal and 75 % university examination.
- b) 75 marks for University assessment means theory papers (Core Courses).
- c) 25 marks for internal assessment of core courses by the University Department/College assessment for sessional work mentioned in syllabus.
- d) To pass the examination a candidate must obtain at least 50% marks in practical/internal and 40% external (Theory Papers) examination of each course/heads separately in all four semesters and aggregate 50% marks.
- e) The Viva-voce examination will have both internal and external examiner.

- f) An external examiner for the evaluation of dissertation will be appointed by Research Recognition Committee (RRC).
- g) The dissertations will be sent to both external and internal for evaluation.
- h) The external and internal shall examine maximum five dissertations.
- i) Research proposal shall be submitted to the University on or before 30th November of first semester.
- j) The candidate shall submit a synopsis to the University signed by university approved guide.
- k) Dissertation work shall be submitted to the University on or before 31st March of fourth semester
- The subject of dissertation (title) shall be approved by RRC. For recommending approval to the subject of dissertation, RRC shall meet in the first week of December of the calendar year to finalize and approve the subject of dissertation.
- m) The candidate shall submit with his/her dissertation a certificate from his/her Guide to the effect-
- i) that the candidate has satisfactory conducted research for not less than two academic years.
- ii) that the dissertation is the result of the candidate's own work and is of a sufficiently high standard.
- iii) that it is satisfactory in respect of literary presentation.
- n) The candidate shall indicate the sources from which his/her information is taken, the extent to which he/she has availed of the work of others and the portion in his/her dissertation which he/she claims to be original.
- o) A maximum of three years from the date of admission to the programme is allowed for programme completion.
- p) The student shall be admitted to next semester as per the following eligibility table:

Note: For calculating the heads, the theory and practical shall be considered as a separate head and on calculation fraction if any shall be ignored.

q) The marks will be converted in grades and credits and finally CGPA.

r) Pattern of Question Paper:

- i. The Syllabus has been divided into four units. There will be four questions and one short note question based on four units to be attempted by the candidate.
- ii. Two questions shall be of long answer type question and three questions shall be of short answer type and shall have equal weightage.
- iii. For every long answer or short answer question type there will be alternative choice from the same unit. However there will be no internal choice in a question.
- iv. Division of marks between long answer and short answer type question will be in the ratio of 40 and 60.
- v. The duration of theory paper of 75 marks shall be of 3 hours.

12. CREDIT AND GRADING SYSTEM

a) Award of Grade:

01 Credit = 25 Marks

01 Credit = 17 Hours for theory course

01 Credit = 34 Hours for practicum / Internal / Sessional

A student he/she shall be assigned a grade based on his/her combined performance in all components of evaluation scheme of a course as per the structure. The grade indicates an assessment of the student's performance and shall be associated with equivalent number called a grade point. The marks of each semester examination for the M. Ed. Course (Theory and practicum) will be converted into grades.

b) GRADING SYSTEM

After adding the internal marks (maximum 25%) to external marks (maximum 75%), the marks secured by a student from maximum 100 will be converted into a letter grade. The grade points are the numerical equivalent of letter grade assigned to a student in the ten points scale as given below:

Calculation of Semester Grade Point Average (SGPA):

- 1. Performance in a semester will be expressed as Semester Grade Point Average (SGPA).
- 2. Cumulative performance of all the semesters together will reflect performance in the whole programme and it will be known as Cumulative Grade Point Average (CGPA). Thus CGPA is the real indicators of a student's performance.
- 3. The formula for calculation of SGPA and CGPA is given below:

C_i - number of credits for the ith course,

Computation of SGPA and CGPA:

The UGC recommends the following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

i. The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e

SGPA (Si) =

(C_i x G_i) / Σ C_i

Where, Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

ii. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

$$\mathbf{CGPA} = \Sigma(\mathbf{C}_i \times \mathbf{S}_i) / \Sigma \cdot \mathbf{C}_i$$

where Si is the SGPA of the ith semester and Ci is the total number of credits in that semester.

- iii. The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.
- iv. The final Class for M.Ed. Degree shall be awarded on the basis of CGPA.

13. Award of Degree:

The degree shall be awarded to the students on the basis of CGPA (Cumulative Grade Point Average) of the four semesters' performance in the exams

- 2) As approved by Rehabilitation Council of India, Delhi (RCI), the government of Maharahstra, Higher & Technical Education Department, Mantralaya, Mumbai has approved the B.Ed. Spl. Education. (H.I) course to Apang Jeevan Vikas Sanstha, Amravati for the session 2014-2015 vide its order No.B.Ed.-4613/ 以.p.,9६४/٩३/मिश-२, दि.२८.२.२०٩४.

Whereas the University Grants Commission, New Delhi, vide its D.O.No.F.-1-1/2014 (Teacher Education) dated 2nd January, 2015 has requested to take all necessary steps to implement all the provision of NCTE Regulation 2014 with effect from the academic session 2015-2016 in the larger interest of the teacher education programmes in the Country,

AND

Whereas, Academic Council in its meeting held on 2/5/2015 vide Item No.34 has noted the NCTE Regulation, 2014 (Recognition Norms & Procedure alongwith its related Appendices. issued by National Council for Teacher Education vide Notification dated 28th November, 2014 & published on Internet by the National Council for Teacher Education, New Delhi,

AND

Whereas, the Board of Studies in Education in its meeting held on dated 7.7.2015 & 13.7.2015 has considered the above NCTE Regulation and resolved to implement the same and revise the syllabus of B.Ed.(Haearing Impairment) course accordingly from the session 2015-2016, and prepared the draft syllabus scheme of Examinations, and provisions to be incorporated in the draft Ordinance for B.Ed. (Haearing Impairment) (Two years) course and recommended to the Faculty of Education

AND

Whereas, the Faculty of Education in its meeting held on 7.8.2015 vide Item No.27 has resolved to accept and recommend to Academic Council, the syllabus, scheme of examinations and provisions to be incorporated in the draft Ordinance for B.Ed. (Haearing Impairment) (Two Years) course.

AND

Whereas, the Hon'ble Vice-Chancellor has accepted the draft syllabi Scheme of teaching and examination, and the provisions to be incorporated in the draft Ordinance of the B.Ed. (Hearing Impairment) course to be implemented from the Academic session 2015-2016 as recommended by the Faculty of Education in its meeting held on 7.8.2015 under section 14(7) of the Maharashtra Universities Act, 1994, on behalf of the Academic Council on dated 8.9.2015.

AND

Whereas, the scheme of teaching & examinations and other provisions for B.Ed.(Haearing Impairment) (Two years) course is required to be regulated by an Ordinance, and preparing the Ordinance for the said course is time consuming process,

AND

Whereas, the admissions of the students in the B.Ed. (Haearing Impairment) (Two years) course are to be made in the affiliated colleges of the University from the academic session 2015-2016,

Now, therefore, I, Dr. M.K.Khedkar, the Hon'ble Vice-Chancellor of Sant Gadge Baba Amravati University Amravati in exercise of powers conferred upon me under sub-section 8 of section 14 of the Maharashtra Universities Act, 1994, do hereby directs as under:-

- 1) This Direction may be called, "Examinations leading to the Degree of शिक्षण स्नातक (Bachelor of Education) (Haearing Impairment) (Semester Pattern) (Two Years Course), Direction 2015".
- 2) This Direction shall come into force with effect from the sessions as under
 - i)Academic Session 2015-2016 for B.Ed.Spl. Education (HI) Semester I & II
 - ii)Academic Session 2016-2017 for B.Ed. Spl. Education (HI) Semester III & IV

3)Eligibility:

A candidate for the degree of B.Ed.(HI) must have passed a Bachelors' Degree examination in any discipline or a corresponding degree examination of any UGC recognized University with minimum 50% in the qualifying degree examination.

4) **Duration:** The duration of the programme is two academic years (four semesters) with 40 credits in each year.

5) Aim and Objectives of the Programme:

The B.Ed.(HI) programme aims to develop special education teachers/educators for children with disabilities and in particular to children with hearing impairment for various educational settings (Inclusive, Special, Open School , Home Based services etc.). The B.Ed.(HI) programme will prepare human resources to enable them to acquire knowledge and competencies to impart effective education to children with hearing impairment and other disabilities with adequate emphasis on education of ALL children. The program further aims to develop special teachers/educators who are able to deliver the best in all the roles like classroom teacher, resource teacher, itinerant teacher, cross disability teacher facilitator.

6) Standard of Passing

- i. The candidate must pass all internals of all parts separately for appearing in semester end theory examination (I/II/III/IV). If the minimum passing mark is in decimal points, the same may be converted to a whole number (Ex. a course of 15 marks internalwill require a minimum pass mark of 08).
- ii. The passing percentage of Part II & III is 50% each in all the four semesters separately. If the minimum passing mark is in decimal points, the same may be converted to a whole number.
- iii. The institution shall have to preserve the record of the internal/sessional work submitted by each student for consecutive three calendar years from the date of his/her admission in the B.Ed. course.
- iv. The marks will be converted in grades and credits and finally CGPA.
- v. To pass the examination a candidate must obtain at least 50% of marks in practical/internal and 40% of marks in university examination (Theory Papers) of each course/heads separately in all four semesters and aggregate of 50% marks in all.
- vi. A maximum of three years from the date of admission to the programme is allowed for programme completion.
- vii. The student shall be admitted to next semester as per the following eligibility table:

7) Grading System:

After adding the internal marks (maximum 30%) to external marks (maximum 70%), the marks secured by a student from maximum 100 will be converted into a letter grade. The grade points are the numerical equivalent of letter grade assigned to a student in the ten points scale as given below,

8. Calculation of Semester Grade Point Average (SGPA):

- 1. Performance in a semester will be expressed as Semester Grade Point Average (SGPA).
- 2. Cumulative performance of all the semesters together will reflect performance in the whole programme and it will be known as Cumulative Grade Point Average (CGPA). Thus CGPA is the real indicators of a student's performance.
- 3. The formula for calculation of SGPA and CGPA is given below:

$$SGPA = \sum_{i} C_i G_i / \sum_{i} C_i$$

$$CGPA = (\sum C_{ni}G_{ni}) / (\sum C_{ni})$$

Where

C_i - number of credits for the ith course,

G_i - grade point obtained in the ith course,

C_{ni} - number of credits of the ith course of the nth semester,

G_{ni} - grade points of the ith course of the nth semester

Computation of SGPA and CGPA:

The UGC recommends the following procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

i. The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e

SGPA (Si) =
$$\Sigma(C_i \times G_i) / \Sigma C_i$$

Where, Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

ii. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

$$\mathbf{CGPA} = \Sigma(\mathbf{C}_i \times \mathbf{S}_i) / \Sigma \mathbf{C}_i$$

where Si is the SGPA of the ith semester and Ci is the total number of credits in that semester.

- iii. The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.
- iv. The final Class for B.Ed.(HI) Degree shall be awarded on the basis of CGPA.

9. Award of Degree:

The degree shall be awarded to the students on the basis of CGPA (Cumulative Grade Point Average) of the four semesters' performance in the exams.

- **12) Fee structure:** As per RCI / University/ State Government / Central Government which ever applicable
- 13) Registered Professional Certificate: It is mandatory for every teacher with B. Ed. (HI) to obtain a "Registered Professional Certificate" from the Rehabilitation Council of India to work in the field of education of children with disabilities in India. Hence, successful candidates of B.Ed. (HI) shall have to register their names with RCI. As continuous professional growth is necessary for the renewal of the certificate in every 5 years, the teachers in this field should involve self in professional development activities like undergoing in-service programmes periodically or publishing articles. Amendments, if any, to the regulations will be made periodically by the Rehabilitation Council of India.
- 14)Provision of Ordinance No. 18 of 2001, relating to provide grace marks for passing in a Head of passing and improvement of Division (Higher Class) and getting Distinction in the subject and condonation of deficiency of marks in a subject in all the faculties prescribed by the Statue No. 18 and of Ordinance No. 10 relating to Examinations and Compartments shall apply to the examinations under this ordinance.
- 15) As soon as possible after the examination, but within 45 days from the last date of examination, the Board of Examination shall publish a list of successful examinees arranged in two divisions. The names of successful examinees shall be arranged in order of merit as provided in the Examination of General Ordinance No. 6.
- 16) Notwithstanding anything to the contrary in this Ordinance, no person shall be admitted to an examination under this Ordinance, if he has already passed that examination or an equivalent examination of any other Statutory University.
- 17) Successful examinees shall, payment of the prescribed fees, receive a Degree in the prescribed form, signed by the Vice-Chancellor.
- **18) Minimum Passing Marks**: Minimum passing Marks for each paper/subject/Internal/Sessional work of B. Ed. (HI) examination leading to the Degree of Bachelor of Education (HI).

19) Framework: Semester Wise Distribution of Various Papers-

- I The programme of B. Ed.(HI) comprises of **Part-I** Theory courses (A,B,C & D), **Part-II** Practical courses (E) and **Part-III** Field engagement (F), which will be covered in four consecutive semesters. The programme structure has four sets of theory courses (A) core courses including two choice based pedagogy courses, (B) Courses in cross disability and inclusion including two optional courses which can be chosen from two pools of courses (C) Disability specialization courses and (D) Courses for enhancement of professional capacities.
- II ATTENDANCE: The programme will be conducted for minimum 180 days each year exclusive of the period of semester end examination and admission. The institution shall work for a minimum of thirty six hours in aweek. Every candidate must have minimum 80% attendance in theory courses and practicum and 90% attendance in field attachment. Every candidate should have to complete all the practical work to the satisfaction of the Head/Principal. He/She should have obtained such certificate from the Head/Principal of the institute and the copy of the same to be submitted to the University by the institution on the behalf of examinees.
