The member secretary acquintated to the committee that, according to the provision vide University direction no. 08/2019, dt. 02/04/2019 there is a provision "Professors/ Associate Professors/ Assistant Professors involved in administration/ extension work can devote two hours per week from the teaching and learning hours". According to this provision, it is imperative to grant exemption to the University teachers those who are engaged in administration/ extension work from teaching and learning hours. The committee has considered the aforementioned provision of the direction no. 08/2019, dt. 02/04/2019 and directed to take necessary action in this regards. As issue related to the Establishment Section, the committee is furthermore directed to communicate the resolution to the Establishment section immediately.
