



FORM OF WRITTEN AGREEMENT

This Agreement made at Amravati on 20/07/2011 between Registrar Sant Gadge Baba Amravati University, Amravati & Contractor M/s. Siddhivinayak V.T.S.S.S. Sasthi referred to as " the Contractor" which expression shall, unless exclude or repugnant to the context, shall include its successors or permitted assigns on the one part and the Sant Gadge Baba Amravati University (herein after referred to as "The University") which expressing shall, Unless excluded or repugnant to the context, include its successors assigns on the other part.

WHEREAS the Registrar Invited tenders according to the power delegated to him as per rules, for the work of Engaging **Skilled Wireman & Helper** for Sant Gadge Baba Amravati University. Hereinafter referred to as 'the said work 'in accordance with the terms conditions, specification connected there to and tender of the contractor in response there to has been accepted by The Registrar Sant Gadge Baba Amravati University, Amravati on behalf of the 'University' being the Competent authority and in pursuance there to a concluded with contractor on the terms and conditions specified in the work order bearing reference Order No. --- "Original Tender and Contract for **Skilled Wireman & Helper** at Sant Gadge Baba Amravati University, Amravati. Connected schedule there to forming part of the tender document submitted by the contractor **NOW THIS AGREEMENT WITNESS AND IT IS**

of Rs. 6,78,900/- (Rs. Six Lacs Seventy Eight Thousand Nine Hundred and 00/100) as made out in the work order placed with him the contractor hereby consents with the University that he shall and will do and perform all works and things under the contract mentioned and described under the said specifications and also which are implied therefore or may reasonably be necessary for the due completion of the said work within and at such time and in such manner and subject to the terms and conditions and stipulations contained and applicable in this contract and "The University" shall arrange to pay the Contractor all the sums of money as and whom they become due and payable to the Contractor under the provisions of this Contract.

AND DECLARES FURTHER THAT

1. The contractor shall hereby undertake the said works providing **SKILLED WIREMAN & HELPER** under Sant Gadge Baba Amravati University, Amravati in a complete and fit manner as more clearly described under the scope of the work together with all ancillary and connected works under this contract.
2. The contractors shall indemnify 'The University' from all claims against any injury caused to any person whether workman or not, while in or upon the works site of work and 'The University' shall not be bounded to defend any claim brought under the 'Workman compensation Act, and 'The Contractor' shall be liable for all such claims as more clearly described in the several conditions of contract.
3. The contractor shall ensure and attain the required Operation and routine maintenance, Since operation and Maintenance & time is the essence of this contract. All the conditions and specifications contained in the printed conditions mentioned hereby including the work order placed on the contractor forming schedule hereto shall be deemed to be part to this contract. The said papers are signed by The Registrar for the University and by, Shri - D. S. Deshpande For M/s. Saakshinagar V.T.N.S. & S. and on behalf of the Contractor for the Purpose of identification.

Terms & conditions

1. The work is to be carried out at Sant Gadge Baba Amravati University, Amravati.
2. Successful bidder has to start the work as per instructions given by University Engineer, Sant Gadge Baba Amravati University, Amravati.

3. Qualifying Criteria

- 3.1 Attested documents are to be submitted as per Technical Bid.
- 3.2 The bidder shall have the experience of similar work in MSEDCL of order amounting Rs. 5.00 Lacs or other Government Semi Government, Private Sector.
- 3.3 **EMD :- A sum of Rs. i.e. 1% of estimated Cost should be deposited as an earnest money deposit in the form of demand draft of any Nationalized / Scheduled Bank in favour of The Registrar, Sant Gadge Baba Amravati University Details of payment of EMD should be submitted along with tender documents.**
- 3.4 Copy of registration under Bombay Shop & Establishment Act to be submitted.
- 3.5 List of technical person along with qualification and experience for contract to be submitted along with bid.
- 3.6 I.T. clearance certificate for last three years, with PAN number.
- 3.7 Registration and latest clearance for Work contract tax and service tax.
- 3.8 Registration under P.F. and labour laws as may be applicable as per relevant act.
- 3.9 Attested copy of registration for ESIC/PF shall be enclosed.
- 4 **Additional documents to be submitted along with the bid**
- 4.1 Solvency certificate issued by nationalized or scheduled bank equivalent to 100% of bid cost of Rs. **Lacs.** should be submitted along with bid.

5. Submission of bids

- 5.1 The bid shall be submitted at University Engineer, Engineering Section. 1IInd Floor Administration Building, at Sant Gadge Baba Amravati University Campus, Amravati.

5.2 Bid should be submitted in the technical & commercial forms as per bid proforma

Bidders should submit the bid well in advance before due date. This office will not be responsible for any delay.

6. Bid Opening

7 Right to accept or reject the bid

- 7.1 The Registrar reserves the right to accept or reject any or all bids and to cancel the bidding process and reject all bids at any time prior to award of contract, without assigning any liability to the affected bidder or bidders or any obligation to inform the affected bidders on the grounds for the employers action.

- 7.2 The Registrar does not bind himself to accept the lowest or any bid, neither will furnish reasons assigned for the rejection.

8. Manpower

- 8.1 Technical person i.e Wireman & helper provided by the agency should be Ex. Apprentice of Board/Company and have pass ITI electrician/ wireman course from a recognized institute preferably NCTVT with one year experience and should be authorized by Electrical Inspector.

- 8.2 Helper provided by the agency should have one year experience of electric Maint./ repairs & Minor works executed with wireman / Electrician.

- 8.3 The deputed manpower should be extremely polite with officer / employees of Sant Gadge Baba Amravati University, Amravati & should be able to address with him.

- 8.4 It will be mandatory for employees of Agency to display the Identity Card nameplate & wear uniform shoes, caps etc. as approved by The Registrar, Sant Gadge Baba Amravati University. Expenditure for Identity card, Nameplate, Uniform, Shoes, Caps & other were borne by agency.

- 8.5 Sant Gadge Baba Amravati University will carry out independent checks, as required.

- 8.6 It is responsibility of contractor to give weekly off to each person. No Wireman/ Helper will be allowed to do over time on any day. No payment for particular duty performed by Wireman / Helper will be made against his weekly off.
- 8.7 Age of Wireman & Helper Provided by the Contractor Shall not be below 18 year & Above 55 year.

9 Contract

- 9.1 The contract period is of 12 month. However the same shall be reviewed after 3 (three) months and it will be decided by Sant Gadge Baba Amravati University to terminate the contract in case of unsatisfactory service by the agency.
- 9.2 Contract Shall be non transferable.

10 Legal

- 10.1 Agency will indemnify Sant Gadge Baba Amravati University, against any liability or damages by way of compensation arising from any accident to person or property of person in the agency employment.
- 10.2 Agency will indemnify Sant Gadge Baba Amravati University, against any liability or damages by way of compensation arising from any accident to person related to or unrelated to agency or Sant Gadge Baba Amravati University.
- 10.3 Agency shall bear the entire responsibility and risk relating to coverage of work force under different statutory regulations including but not limited to workman compensation Act, ESIC Act, **Minimum wages Act**, Contract , etc. and other relevant regulations, as the case may be.
- 10.4 Agency shall be fully responsible for payment of benefits including but not limited to Provident Fund, Bonus, Retrenchment Compensation, Leave Encashment, etc. as per statutory provisions.
- 10.5 Necessary payment and liabilities shall be the responsibility of agency irrespective of payment received from Sant Gadge Baba Amravati University or otherwise.
- 10.6 All taxes and dues payable to government and or local authorities in respect of these works shall be the responsibility of agency and the agency will have to indemnify Sant Gadge Baba Amravati University against liability on account of such levies or taxes.
- 10.7 In the event, agency is not in a position to complete the contract or any part of contract for any reason whatsoever, Sant Gadge Baba Amravati University will make alternate arrangement to complete the work at the cost, risk and responsibility of agency, together with a fine Rs. 2000/- per person per month each time. Contract will be automatically terminated at 3rd such event. The decision of competent authority will be final & binding to all.
- 10.8 Adequate precaution shall be taken by the persons engaged by the agency to prevent damage to any of the equipments / property of Sant Gadge Baba Amravati University. in case of damage same will be recovered from agency.
- 10.9 The agency shall apprise the persons engaged in clear terms that they shall not be entitled to claim any requirement for whatsoever post / vacancy or lien over any such post / vacancy in Sant Gadge Baba Amravati University in any manner.
- 11. **All** dispute and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after its completion and whether before or after the determination of contract, shall be referred by the contractor to the University Engineer. He shall after receipt of the contractors representation make and notify decisions of all matters referred to by the contractor in writing. The decision of The Registrar will be final and binding to all.

12. Rate

- 12.1 Agency shall quote all-inclusive rate per technician / Helper per Shift of 8 Hrs. Per day. Sant Gadge Baba Amravati University will not pay any amount over and above the quoted rates. Hence the rate should cover all statutory / non-statutory levies, taxes etc. In case any taxes and levies are required to be paid directly by Sant Gadge Baba Amravati University, the same will be debited from agency bill / S.D for making necessary payment by Sant Gadge Baba Amravati University.
- 13. **Security Deposit:-** The successful tenderer will have to deposit 5% of the contract value as Security Deposit by Demand Draft within stipulated time from the date acceptance of the tender. The same will be refunded/discharged after 3 Months of successful execution of work, Failure to pay the security deposit would result into the forfeiture of earnest money deposit

- 15 Guarantee**
All services to be provided are to be guaranteed for correctness and conductance as per acceptable norms and in the event of any failure on the part of agency, Sant Gadge Baba Amravati University, will be entitled to terminate the contract at risk and cost of Agency. Further necessary legal course of action, as deemed fit; will be taken for recovery of Sant Gadge Baba Amravati University dues.
16. **Agreement :-** Agency have to execute an agreement on stamp paper of Rs.100/- before starting the work.
- 17 **Dispute :-** For any type of dispute arising during course of contract, the decision of the undersigned will be final & binding upon Agency, subjected to jurisdiction of Amravati Court only.
18. Taxes :- Income tax as per rules shall be deducted from your bill.
19. **Insurance :-** The agency shall undertake the insurance of adequate amount for all his persons during the entire period of contract or extended period of the same if necessary.
- 20 Special condition**
- 20.1 The agency shall furnish the bid security 1% of the estimated value as a part of bid.
- 20.2 The EMD will be forfeited in case of I) if the bidder withdraws his bid during the period of bidding process. II) In case bidder fails to fulfill tender conditions, if he fails within the specific time limit to furnish the required performance security.
