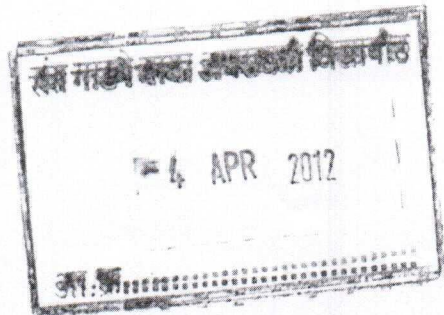

In exercise of powers conferred under section 14(9) of Maharashtra Universities Act, 1994, the Hon'ble Vice-Chancellor, on recommendations of the Selection Committee constituted u/s 76 of the Act, is pleased to appoint Smt. Sujata Nishikant Kale as a Lecturer (Open Category) on an initial Pay of Rs.8000/- in the pay scale of Rs.8000-275-13500/- in Applied Electronics in the Department of Applied Electronics on the conditions given below :

1. She shall be on probation for a period of two years subject to continuation of post and satisfactory working. During the period of probation, her services can be terminated by giving a month's notice. Similarly she may resign the post by giving a month's notice.
2. She should join the duties by 20th January 2001 unless extended on genuine request, failing which this order of appointment shall be treated as cancelled.
3. She shall be entitled for usual allowances admissible from time to time.
4. On joining, she shall have to produce the following documents :-
  - a) Original Degrees/ Diplomas and other testimonials about her academic attainments.
  - b) Medical fitness certificates from Civil Surgeon/Member of University Medical Board.
  - c) Relieving certificate from the present employer.
  - d) She should execute an agreement with the University, at the time of appointment.

The expenditure on account of salary and allowances shall be held admissible from the State Government Grants.
