authority. (Schedule-I)

Sir/Madam.

- 1) The Maharashtra Public Universities Act, 2016 (hereinafter referred as 'the Act') came into force from 1st March, 2017. The Govt. of Maharashtra, in the light of provisions made u/s 27 of the Act, has issued eligibility conditions for being elected, nominated or co-opted as a member of any authority of the university as mentioned under reference at above. Now, the process of election to university authorities is going to commence with the preparation of provisional electoral roll of persons, entitled to vote at an election to the authorities or bodies of the university.
- 2) As per the following provisions of section 40(2)(c) of the Act and the respective eligibility conditions mentioned at above, the Three Heads of Departments from affiliated colleges are to be elected from amongst collegiums of heads of departments of affiliated colleges, on the Boards of Studies.

Section 40(2)(c): "THREE heads of departments from affiliated colleges and recognized institutions to be elected from amongst the collegiums of heads of departments of affiliated colleges and recognized institutions."

Eligibility conditions: "Elected from Collegiums of Heads of Departments of Affiliated Colleges and Recognised Institutions -

- (a) Shall possess Ph.D. Degree, unless he is a Principal appointed as a Principal before 13th October 2000,
- (b) Shall have at least ten years teaching experience at undergraduate level in aggregate,
- (c) Shall have undertaken university examination related work for at least five years in aggregate."
- 3) The Direction No. 21, 22 and 23/2022 in respect of 'Constitution of faculties', 'List of subjects comprised in each faculty' and 'Assigning of various Boards of Studies to the faculty' respectively are enclosed herewith for reference. (Annexure-A, B and C respectively)
- 4) The terms "Head of Department", "College", and "Department" are defined under para 3 of Direction No. 30/2022 in respect of 'Procedure for election of Three Heads of Departments in affiliated Colleges on Board of Studies' read with the term "Seniority" as defined under para 4 of Direction No. 38/2022 are also enclosed herewith for reference. (Annexure-D & D1)
- 5) Annexure-E (Page No.G-7028) annexed herewith is for designating Heads of Departments by you for inclusion of their names in the electoral roll for the elections to the Boards of Studies.

- 6) Annexure-F (Page No.G-7029) annexed herewith regarding declaration is to be filled in by the teacher who is to be designated by you as Head of the Department for inclusion of his/her name in the electoral roll for elections to the Boards of Studies.
- 7) Annexure-G (Page No.G-7030) annexed herewith is for designating the teacher by you as Head of the Department if he/she is not senior most teacher in the department.
- 8) Annexure-H (Page No.G-7031) annexed herewith is for designating yourself as Head of the Department, if you are senior most teacher in the department.
- 9) What is to be done by yourself?
 - (a) Get Annexure-F, duly filled in, with reference to Annexure, annexed with Direction No. 23/2022, from the teachers to be designated by you as Head of the Department & submit them to the University.
 - (b) Fill in Annexure-E, with reference to Annexure, annexed with Direction No. 23/2022, for designating Heads of Departments and submit it them to the University.
 - (c) Fill in Annexure-G, if necessary, with reference to Annexure, annexed with Direction No. 23/2022, and submit it/them to the University.
 - (d) Fill in Annexure-H, if necessary, with reference to Annexure, annexed with Direction No. 23/2022, and submit it to the University.
 - (e) Before submitting Annexures-E & F and Annexures-G & H, if necessary, to the University on or before 5.00 p.m Monday, the 5th Sept., 2022. Please ensure that other members of the teaching staff in the concerned subject are informed about the name of designated Head of the Department. For this purpose, Annexure-E, and if necessary, Annexures-G & H prepared for their submission to the University be circulated amongst the teachers of the concerned subject and the acknowledgment be obtained from them as an evidence that they have no objection to the name of the designated Head of the Department.
 - (f) Annexures-E, F, and if necessary, Annexures-G & H be sent to the undersigned through messenger only.

Whereas, "Maharashtra Public Universities Act, 2016" has been implemented for Non-Agricultural Universities in the State,

AND

Whereas, the Higher & Technical Education Department of Maharashtra has been directed to implement the said Act with effect from 1st March, 2017,

Whereas, for the time being, Vice-Chancellor have the power to regulate the matter by issuing direction under the provision of sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016,

AND Whereas, Direction Nos. 17/2017 and 9/2018 in respect of Assigning of various Boards of Studies to

the Faculties were issued on 3.7.2017 and 24.1.2018 respectively,

Whereas, the proviso of sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 provides that such direction to be converted into related statutory forms within six months and failing which such direction shall be automatically lapsed,

AND

Whereas, the Statute Committee have the power to prepare the draft Statute and place it before the Management Council under sub-section (2) of Section 72 of the Maharashtra Public Universities Act, 2016,

AND

Whereas, the draft Statute in respect of Assigning of various Boards of Studies to the Faculties is under consideration of the Statute Committee,

AND

Whereas, making Statute in this respect is a time consuming process,

Whereas, meanwhile in view of transacting day to day business, it is necessary to issue the direction in respect of Assigning of various Boards of Studies to the Faculties,

AND

Whereas, the Academic Council in its meeting dated 13.1.2020, vide item No. 4 has resolved that a fresh Direction shall be issued by superseding earlier direction if the relative legislation not be made in a stipulated period,

AND Whereas, Facultywise four Committees constituted on 14.7.2020 by Hon'ble Vice Chancellor, for prescribing List of Subjects comprised in each Faculty and Boards of Studies to the Faculties, have submitted their recommendations and meanwhile minor modifications were made in the list of Boards of Studies assigned to the Faculties in consultation with the Dean of the respected Faculty.

Now, therefore, I, Dr. Dileep N. Malkhede, Vice Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under sub-section (8) of Section 12 of Maharashtra Public Universities Act, 2016, do hereby directs as under;

- This Direction may be called, " Assigning of various Boards of Studies to the Faculties constituted (i) under the provision of Maharashtra Public Universities Act, 2016, Direction, 2022".
- This Direction shall come into force with effect from the date of its issuance. (ii)

Subject: Procedure for election of Three Heads of Departments in affiliated colleges on Board of Studies.

Whereas, Maharashtra Public Universities Act, 2016 (hereinafter referred as the "Act") come into force w.e.f. 1st March, 2017;

AND

Whereas, the procedure regarding constitution of various authorities in the University needs to complete in the light of provisions of sub section (2) of section 62 of the Act;

AND

Whereas, elections of Three Heads of Departments on Board of Studies is one of the parts of the constitutions of various authorities;

AND

Whereas, the eligibility conditions for being elected as a member of the authority are specified by Higher and Technical Education Department, Mumbai in exercise of the powers conferred by the section 27 of the Act;

AND

Whereas, the definition regarding "Heads of the college department" is required to be prescribed by the Statute;

AND

Whereas, the original Statute- 18, 19 and 23 are repealed by issuing Direction Nos. 15, 16 and 17 of 2017 respectively. But taking into consideration of the proviso of section 12(8) of the Act, the said Directions were automatically lapsed, failing to convert into respective legislation in stipulated time.

AND

Whereas, again issued Direction Nos. 7, 8 & 9 in the year 2018 and 21, 22 & 23 in the year 2022 repealing the original Statute- 18, 19 & 23 respectively;

AND

Whereas, the procedure for elections of Six Heads of Departments in colleges on Board of Studies u/s 37(2)(b) of the Maharashtra Universities Act, 1994 prescribed by Statute No. 11 of 2000 is inconsistent with the provisions of the Maharashtra Public Universities Act, 2016. Hence, it is required to repeal and formulate a new Statute in the light of provisions made under the respective section of the Act;

AND

Whereas, Direction No. 18/2017 dt. 5.7.2017 in this regard, was used for first time in the previous election i.e. authorities elections-2017, which was converted into draft Statute No. 2/2021 by Statute Committee and recommended to the Management Council and the Senate. The Senate in its meeting held on 12.3.2021 vide item No. 88, referred back the said draft Statute, which was reconsidered and recommended as it is, by the Statute Committee. The Management Council in its meeting held on 2.3.2022 (adj. of 22.2.2022) vide item No. 42, recommended the same to the Senate. But it could not possible to place before the meeting of the Senate held on 11.3.2022 as minutes of the Management Council was not received in a stipulated period. The said draft Statute will be submitted to Hon'ble Chancellor's office after the approval of the Senate.

AND

Whereas, making of Statute is a time consuming process.

Now, therefore, I, Dr. Dileep N. Malkhede, Vice-Chancellor of the Sant Gadge Baba Amravati University in exercise of powers conferred upon me u/s 12(8) of the Maharashtra Public Universities Act, 2016, issue the following direction:-

- 1. This Direction may be called "The Procedure for election of Three Heads of Departments in affiliated colleges on Board of studies, Direction, 2022"
- 2. The Direction shall come into force with effect from the date of its issuance.
- 3. In this Direction, unless the context otherwise requires;
 - (a) "Head of Department" means the senior most teacher in the department of affiliated college designated as such by the Principal.

Provided firstly that, if the Principal wants to designate any teacher other than the senior most teacher, he may do so after recording reasons in writing and with the approval of the Management Council.

Provided Secondly that, no person shall be designated as the Head of the Department of more than one subject.

Provided thirdly that, the Principal may designate himself as Head of the Department if he is a senior most teacher in the department.

- (b) "College" means a affiliated college as specified under section 2(3) by the Maharashtra Public Universities Act, 2016 for the subject/s and the courses of study approved for affiliation and which has sent candidates for the Final Examination of the first degree in the Faculty.
- (c) "Department" means a department teaching a particular subject or a group of subjects in a college which comprised in a Board assigned to the Faculty.
- 4. The eligibility conditions for being elected as a member under the category 'Three Heads of Departments' elected from collegiums of Heads of Departments of affiliated colleges and recognised institutions -
 - (a) shall possess Ph.D. degree, unless he is a Principal appointed as a Principal before 13th October, 2000,
 - (b) shall have at least ten years teaching experience at undergraduate level in aggregate,
 - (c) shall have undertaken university examination related work for at least five years in aggregate.
- 5. There shall be separate ballot for each Board of Studies.
- 6. On a request made in this behalf by a letter and/or public notification, the Principal shall furnish to the Registrar within such time as may be specified in the request, the list of names of Heads of Departments eligible to vote in the election under section 40(2)(c) of the Act, giving such particulars as the Registrar may specify, with subject and faculty in which he is appointed and enrolled as an elector.
- 7. On receipt of this information, the Registrar shall prepare separate electoral roll for the Boards named in Annexure annexed with Direction No. 23/2022 dt. 31.3.2022
- 8. The Registrar shall publish the provisional electoral rolls as specified in Uniform Statute No. 1 of 2017.
- 9. Hereinafter, the Statute No. 11 of 2000 shall stand repealed.

Norms for determining the seniority amongst the teachers in each Teaching Department of the University, conducted colleges, affiliated colleges, model, autonomous colleges and recognized institutions and for assigning addl. Charge of Principal's post Direction 2022.

Whereas, it is necessary to prescribe the norms to determine the seniority amongst teachers defined u/s 2.(61) of Maharashtra Public Universities Act,2016 for the purpose of nomination as Head in each Teaching Department of the University, conducted colleges, affiliated colleges, model, autonomous colleges and recognized institutions and to assign the Additional Charge of Post of the Principal.

AND

Whereas, Section 2 (31) and Section 2(61) of the Maharashtra Public Universities Act, 2016 respectively provide the definition of 'Head of Department' and 'teacher' and Section 2(24) provides definition of the "Department".

AND

Whereas, the University Grants Commission's Regulation – 2018 as accepted by the Government of Maharashtra vide Government Resolution dated 8th March 2019 prescribe the qualifications and eligibility for the appointment of the teachers in respective cadres i.e. Assistant Professor, Associate Professor, Professor, Sr. Professor in the University Teaching Departments and the same cadres (excluding senior Professor) for affiliated colleges and Principal of the College. So also, Academic Levels in these cadres have been prescribed;

AND

Whereas, at present Statute No. 55 vide Para-3 for designating Head of Department in the University Departments is in existence but it further needs to be more specific. Further, there is no Statute on this subject for colleges / Institutions. Further the provisions vide para-17 of original Ordinance No.122 on Seniority regarding college/University Teachers also needs to be more specific.

AND

Whereas, the Govt. Resolution dated 30 July 2010 provides that the Professor shall be the Head of the Department as he holds the higher Post than the Associate Professor.

AND

Whereas, the Academic Council in its meeting held on 04.12.2020 vide Item No. 96 (A) directed to study at administrative level and issue the Direction regarding Head of Teaching Department in affiliated Colleges referring the said G.R. dated 30.07.2010 and Direction of North Maharashtra University, Jalgaon;

AND

Whereas, the Govt. has issued the G.R. dated 15th March, 2012 for handing over the additional charge of the post of Principal of the college as per seniority if there is no teacher available in the college fulfilling requisite qualification for the post of Principal, or there are more than one teacher Possessing requisite qualification for the post of Principal.

AND

Whereas, it is necessary to prescribe norms for determining the seniority of teachers for the purpose of nomination as Head of the Teaching Department in University and affiliated colleges / Institutions and for assigning additional charge of the Principal's post in college / Institution.

AND

Whereas, the Management Council vide Item No.104, in its meeting held on 23rd July, 2022 has considered the draft norms, and authorized the Vice-Chancellor to finalise the same;

AND

Whereas, the Vice-Chancellor has finalized the norms which are to be prescribed by Statute and process of prescribing the same, takes time;

Therefore, I, Dr. Dileep Malkhede, Vice Chancellor, Sant Gadge Baba Amravati University Amravati, in exercise of powers vested in me u/s 12 (8) of the Maharashtra Public Universities Act, 2016, do hereby issue the following Direction:-

- 1. This Direction may be called as "Norms for determining the seniority amongst the teachers in each Teaching Department of the University, conducted colleges, affiliated colleges, model, autonomous colleges and recognized institutions and for assigning addl. Charge of Principal's post Direction 2022";
- 2. This Direction shall come into force with effect from the date of its issuance;
- 3. In this Direction, unless the context otherwise requires;
 - (a). "Act" means the Maharashtra Public Universities Act, 2016.
 - (b). "Government Resolutions (GR)" mean Government Resolutions (1) No. NGC 2010/(415/10)UN-1 dated 30th July, 2010", (2) No.Misc.2018/CR-56/18/UNI-1 dated 8th March, 2019, and (3) No.Niyukti-2011/pra.kra.344/11/Ma.shi.-5 dated 15 March, 2012 of Higher and Technical Education Department.
 - (c). "Head of the Department" means as defined u/s 2 (31) of the Maharashtra Public Universities Act, 2016 and "Department" as defined u/s 2(24) of the Act.
 - (d). "Seniority" means the seniority amongst the teachers in the University and the Colleges as prescribed vide Para-21.0 (c) of Government Resolution dated 8th March, 2019 mentioned at (b) above.
 - (e). 'Teacher' means Teacher as defined u/s 2.(61) of the Maharashtra Public Universities Act, 2016.
 - (f). "UGC Regulation" means the UGC Regulation 2018 as accepted by Government of Maharashtra vide Government Resolution dated 8th March, 2019 mentioned in (b) above.
 - (g). "Cadre" means cadre of Senior Professor, Professor, Associate Professor, Assistant Professor, other equivalent teaching posts in Department of Library & Information Science and Physical Education & Sports, and the Principal, as provided in para-4.2 of G.R. dated 8th March 2019, mentioned in (b) above.
- 4. For the purpose of nominating the teacher as defined u/s 2(61) of the Act in University, colleges. Institutions as Head of the Department (HOD), it shall be on the basis of seniority determined, as per the following norms:-
 - (1) Nomination shall be made by the Vice-Chancellor / Management of the College / Institution, as the case may be.
 - (2) For University Teaching Department /Conducted College of University Seniority of the teachers in the respective cadre in each teaching department of the University and conducted College of University shall be
 - a. Sr. Professor shall be senior to the Professor
 - b. Professor shall be senior to the Associate Professor:
 - c. Associate Professor shall be senior to the Assistant Professor
 - (3) For Teaching Department of affiliated College/recognized Institutions Seniority of the teachers in the respective cadre in each teaching department of the affiliated College/Institution shall be -
 - i) Professor shall be senior to the Associate Professor.
 - ii) Associate Professor shall be senior to the Assistant Professor.
 - iii) Principal in Professor grade shall be senior to the Principal in Associate Professor grade.
 - iv) Principal in Professor grade shall be senior to the Professor.
 - v) Principal in Associate Professor grade shall be senior to the Associate Professor,
 - vi) Professor shall be senior to the Principal of Associate Professor grade

Provided that, in all administrative matters, the Principal / Director of the college / Institution shall be considered senior over all the teachers in the college/ Institution.

- (4) For the purpose of assigning additional charge of the post of Principal it shall be subject to provisions in the GR dated 15 March 2012 by following the criteria of qualification and to a senior most teacher amongst all teachers in the concerned college/ Institution
- (5) The college/Institution should maintain the seniority list of teachers having regard to the provision vide Para 21.0(c) of G.R. dated 8th March 2019 mentioned in Para 3(b) above.
- (6) In case of equal length of service, the seniority of the teacher:
 - (A) within the Department/colleges/Institutes, it shall be considered on the basis and in order of
 - i) Teacher having prior date of joining in that cadre shall be senior.
 - ii) If the date of joining is same, teacher having prior date of birth shall be senior.
 - iii) In case of same date of birth, the higher API score as certified by IQAC shall be considered.
 - iv) In case the identical API, the higher marks obtained by the teacher in the interview of that respective cadre shall be considered.
 - v) In case of similarity of the marks, the seniority will be as determined by the Vice Chancellor in respect of Teachers in University Teaching Department/Conducted College or the Management of the College in respect of affiliated college/recognised institution teachers, as the case may be
 - (B) The same Criteria mentioned vide (6) (i) to (v) above, shall also be followed in respect of assigning the additional charge of Principals post.
- (7) While determining the seniority of the teachers, only teachers appointed on any substantive post of teacher shall be considered.
- (8) The respective higher position held by the teacher as in-charge, additional charge, temporary position assigned, shall not be taken into consideration to determine the seniority.
- (9) The teacher disqualified under any of the rules of the University that makes him / her disqualified to be the part of university authority shall not be considered for the purpose under this Direction.
- (10) All the relevant information for determining the seniority shall be taken from the service book of the teacher.
- (11) After nomination as per seniority as mentioned above, if the teacher of higher position in seniority in the cadre is available subsequently, then he/she shall be the Senior, for the purpose under this Direction.
- (12) If any punishment or disqualification accrued to the Head of the Department subsequently, he/she shall be deemed to be removed from the date of such Notification, and next senior teacher shall be nominated by the Vice Chancellor or Management of the College/ Institution, as the case may be.
- (13) No teacher shall be nominated under this Direction, as Head of the Department for more than one Department. However, in exceptional case, the Vice Chancellor or Management of the College may assign additional charge of other Department to any teacher. However, this additional charge shall not accrued any further nomination on any other University authority.
- (14) In case of any dispute or interpretation of the clause to determine the seniority, the same shall be referred to the Vice Chancellor whose decision shall be final and conclusive.
- 5. As Soon as this Direction come into force, the provisions made in it shall prevail and the provisions made hereinbefore in the Original Statute No.55 and the Original Ordinance No.122 or in any other Statutes, Ordinances, Directions, etc shall to the extent to which they are inconsistent with the provisions of this Direction, be void.
