




- 1) Tenders are invited from the certified Energy Auditors registered & empanelled with Maharashtra Energy Development Agency (MEDA)
- 2) This tender is published on 4/12/2025 & last date of submission of tender through E-tender is 22/12/2025 upto 1.00 p.m. probably opening date of received tender is 24/12/2025 at 01.00 p.m. Tender will be opened at E-Tender Room at the office of the Executive Engineer, Administrative building, Sant Gadge Baba Amravati University Campus, Amravati.
- 3) Cost of blank tender form & EMD shall be submitted through online mode only.
- 4) It is mandatory for all tenderers visit all the work site in University campus and have understood the scope of work, work places, working hours etc. and obtaining site visit/ survey report duly signed by University Deputy Engineer (Elect.). This site visit / survey report must be submitted with Envelope No.1 (Technical BID) of tender. If this report is not submitted by the tenderer, then the tender will be outrightly rejected.
- 5) Tenderer should upload the documents & rate on www.mahatenders.gov.in.
