- 2) The suppliers should submit the quotation contain their price offer (rates) on the prescribed quotation form. These envelopes should be enclosed in envelope.
 - a. Demand Draft of **Quotation deposit of Rs. 1000/- of Total cost of quoted value** in favour of Finance & Account Officer, Sant Gadge Baba Amravati University, Amravati or Certificate of exemption for earnest money deposit if applicable. The suppliers availing the facilities of exemption shall have to deposit Rs. 5000/- on the total cost of approved rates as security deposit after acceptance of their rates.
 - b. Authorized Fabricator's should submit the attested zerox copy of Valid Authorization Certificate.
- 3) The quotation form shall be accepted along with demand draft for Rs. 500/- as a cost of Quotation form (Non-refundable) drawn in favour of **Finance & Account Officer, Sant Gadge Baba Amravati University** payable at Amravati
- 4) The incomplete / conditional Quotation will not be considered.
- 5) The suppliers should quote rate each M.S. Tree Guard.

- 10) If suppliers fail to deliver the goods within the time specified in the order or replace the rejected goods in time, we are at liberty to purchase the ordered goods from the open market without giving any prior notice & if compelled to purchase at the higher price than your approved rates such losses shall be recovered from the E.M.D., S.D. or any outstanding payment of the suppliers.
- 11) Weight/Quality/Quantity of the materials will be confirmed after our physical checking at our Garden Section & if the shortage is found, amount will be deducted from the invoice.

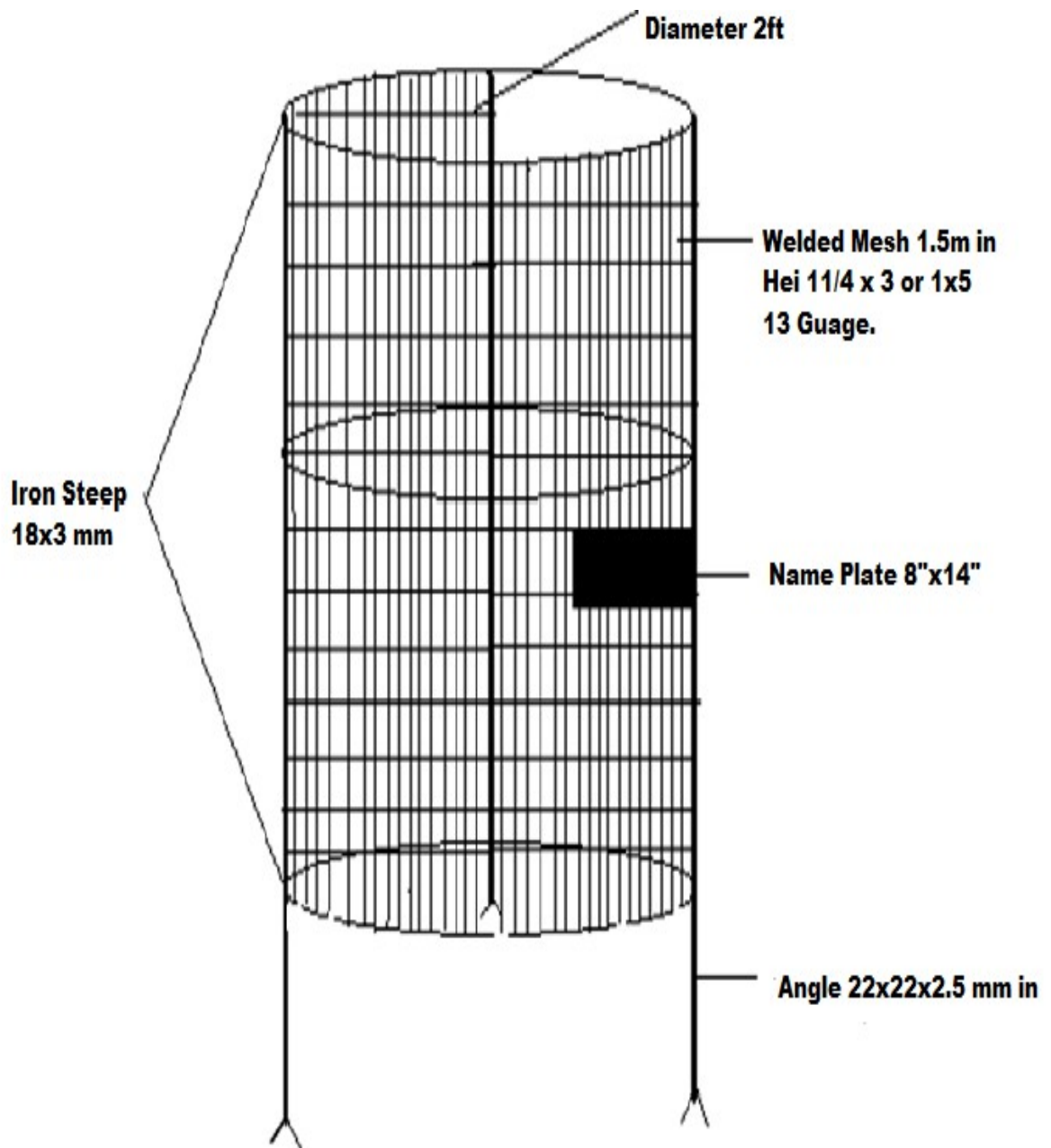
