<u>Sub</u>:- Revised Application Fee for opening new college/course etc. and fees for grant of 1<sup>st</sup> time affiliation to new college (with Reserve Fund & Building Fund); new Courses, Subjects, Faculty etc./Continuation of affiliation (annually); intake capacity; addl. Division; natural growth etc./Autonomous status; and other fees, to colleges Direction – 2025

Whereas, the fees and Funds for the purpose of opening of new colleges; grant of affiliation to new colleges; existing colleges and autonomous status, in the jurisdiction of the University are charged since previous Universities Acts, and now under the provisions of Section – 73(3) r/w Section 109, 110, 114, 115 and 122 of present Maharashtra Public Universities Act, 2016, by issuing the Directions u/s 12 (8) of the Act, on the above subject, from time to time.

# AND

Whereas, recently, the University has issued the Direction No. 35/2024 dt. 16/8/2024, on above subject, and the proposal of revising the fees was under preparation by the Committee appointed by the Hon'ble Vice-Chancellor, which has submitted the proposal,

### AND

Whereas, on the said proposal, the Board of Deans vide Item No. 58 of 22/8/2024 meeting r/w its Item No. 61 of 23/9/2024 meeting has recommended the aforesaid proposal to the Academic Council for consideration and approval.

### AND

Whereas, the Academic Council vide item No. 56 of 3<sup>rd</sup> September, 2024 meeting r/w its Item No. 76 of 25 September, 2024 meeting has considered the proposal recommended by the Board of Deans, and approved the Revised Fee/Fund u/s 32(1) and 33(1) (m) of the Act, vide Page No. C-8604 to C-8606 (by deleting Appendix-E Table only of Part-I on Page No. C-8606), thereby prescribed the Fees/Fund under Part-I Appendix – A and fees under B, C and D with Note below deleted Appendix – E; and illustrations and Part –II Appendix – A, and directed to withdraw the Direction No. 35/2024 which is enforced from Academic session 2024-25,

# AND

Whereas, the Academic Council has prescribed the Revised Fees/Fund as mentioned above u/s 32(1) and 33(1) (m) of the Act.

# AND

Whereas the matter is to be prescribed by Ordinance u/s 73(3) of the Act, process for which shall take time and the matter it is to be implemented from 2024-2025 academic session by withdrawing present Direction No. 35/2024 hence the Direction No. 76/2024 has been issued u/s 12(8) of the Act. Thereafter the Academic Council in its meeting held on 03/10/2024 has resolved to prescribed fee for "Closure of Programme in Appendix –D col. No. 7 of Direction No. 76/2024 as Rs. herewith".

Therefore, I, Dr. Milind Barhate, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati do hereby issue the following Direction;

- 1. This Direction may be called as "Revised Application Fee for opening new college/course etc. and fees for grant of 1st time affiliation to new college (with Reserve Fund & Building Fund): new Courses, Subjects, Faculty etc./Continuation of affiliation (annually): intake capacity: addl. Division; natural growth etc./Autonomous status; and other fees, to colleges Direction -
- 2. This Direction shall come into force from 30th March, 2025 keeping inforce to continue the revised fee and fund from academic session 2024-2025 & onward.
- 3. In this Direction, unless the context otherwise requires:
  - a) "Act" means" Maharashtra Public Universities Act. 2016."
  - b) "Academic Council" means "Academic Council constituted u/s 32 of the Act.
  - e) "Affiliated College" means " college to which affiliation is granted by the Academic Council u/s 110 of the Act, as defined u/s 2(3) of the Act.
  - d) "First Time affiliation to college" means "affiliation granted to proposed new college as approved by Government u/s 109 (3) (g), r/w Section 110, of the Act.
  - e) "First Time affiliation to new courses of study, subjects, faculties, additional divisions" means " to which the Government has approved for starting them newly colleges u/s 109 (4)(a) and (d) r/w Section 115 & 110 including Section 108 (8) of the Act.
  - f) "Continuation of affiliation" means "continuation of affiliation granted to college annually u/s 110 r/w Section 114 of the Act.
  - g) "Autonomous college" means, "an affiliated college to which the autonomous status is granted u/s 122 of the Act.
- 4. The Revised Fees/Building Fund, Reserve Fund on the subject mentioned above, under Part-I Appendix-A, and Revised Fees under Appendix-B, C and D (as modified by Academic Council) of Part-I, and Fees under Part-II Appendix - A, as approved by the Academic Council, appended with this Direction, shall prevail, from the Academic Session 2024-2025 & onward sessions, and the Fees/Reserve & Building Fund prescribed in any Ordinance/Direction upto 2023-2024 session to the extent to which they are repugnant to the Fees/Fund prescribed under this Direction, shall be null and void.
- 5. While framing Ordinance u/s 73(3) of Maharashtra Public Universities, Act, 2016, exclusively on fees for grant of affiliation, the fees prescribed for Permanent affiliation as per its concerning Direction, shall be incorporated.
- 6. The Direction No. 35/2024 stood withdrawn already, from 1st Direction No. 76/2024.
- 7. The earlier Direction No. 76/2024 stands lapsed after completion of 6 month period under the provisions of section 12 (8) of the Act.
