Ordinance No. 2 of 2014.

Examinations leading to the Degree of वाड्.मय पारंगत (Master of Arts) (Functional English) (कार्यात्मक इंग्रजी) (Two years course) Ordinance, 2014.

Whereas, it is expedient to make an Ordinance in respect of Examinations leading to the Degree of वाड्.मय पारंगत (Master of Arts) (Functional English) (कार्यात्मक इंग्रजी) (Two years course) in the faculty of Arts, for the purposes hereinafter appearing, the Management Council is hereby pleased to make the following Ordinance.

- 1) This Ordinance may be called "Examinations leading to the Degree of वाड् मय पारंगत (Master of Arts) (Functional English) (कार्यात्मक इंग्रजी) (Two years course) Ordinance 2014".
- 2) This Ordinance shall come into force with effect from the date of its approval by the Management Council.
- 3) The duration of the course shall be of two academic years as M.A.Part-I and the M.A.Part-II. The examinations shall be held twice a year.
- 4) The examination referred in para (1) above shall be held at such places and on such dates as may be fixed by Board of Examinations.
- 5) (A) M.A.Part-I (Functional English) examination course should possess a Bachelor Degree of the University or of any other university or an examinations recognised as equivalent thereto and have prosecuted a regular course of study of not less than one academic year in a College/University Department since his/her passing, the preceding examination.
 - (B) M.A.Part-II(Functional English) (वांड.मय पारंगत (कार्यात्मक इंग्रजी) भाग-२) course, the candidate shall have passed the M.A.Part-I (Functional English) (वांड.मय पारंगत (कार्यात्मक इंग्रजी) भाग-१) examination of the university..
- 6) Without prejudice to the other provisions of Ordinance No.6 relating to the Examinations in General, the provisions of paragraphs 5, 8, 10, 27 and 32 of the said Ordinance shall apply to every collegiate candidate.
- 7) An applicant for the examinations pursuing a regular course of study in the degree of M.A. (Functional English) shall not seek admission to any other course in any University /College or shall not appear in any other examination simultaneously.
- 8) The examination fee and other fees shall be as prescribed by the University from time to time.
- 9) The scope of the subjects and scheme of teaching and examinations for the said course shall be as prescribed in Appendix-A appended to this Ordinance.
- 10) The medium of instructions and examination shall be English only.
- An examinee who is unsuccessful at the examination shall be eligible for re-admission with fresh fee prescribed for the examinations together with other related fees.
- Provision of Ordinance No.18 of 2001 relating to an Ordinance to provide grace marks for passing in a Head of passing and Improvement of Division (Higher Class) and getting Distinction in the subject and condonation of the Deficiency of marks in a subject in all the faculties prescribed by the Statute No.18, and Ordinance No. 10 Providing for Exemption and Compartments shall apply to the examinations under this Ordinance.

- Examinees successful in Part-II examination, obtaining 60% or more marks in the aggregate in Part-I and Part-II taken together shall be placed in the First Division. Those obtaining less than 60% but not less than 55% marks in the Higher Second Division. Those obtaining less than 55% but not less than 48% marks in the Second Division and all other successful examinees in the Third Division.
- As soon as possible after the examinations, the Board of Examinations shall publish a list of successful examinees at the examinations as provided under section 72 of Maharashtra Universities Act, 1994. The list of examinees successful at the M.A.Part-I & Part-II examinations shall be arranged in division. The names of examinees passing the examinations in whole in the minimum prescribed period and obtaining the prescribed number and placed in the first or second division shall be arranged in order of merit as provided in the Examinations in General Ordinance No.6.

Provided that, the merit list shall only be published for Summer Examination.

- Notwithstanding anything to the contrary in this Ordinance, no person shall be admitted an examinations under this ordinance, if he / she has already passed the same examination or an equivalent examination of this University or any other University.
- Successful examinees at the Part I and Part-II examination shall on payment of the prescribed fees receive a Degree in the Prescribed form signed by the Vice-Chancellor.

- 1. This course is for regular students only. No external students will be permitted.
- 2. In paper IV and VIII the candidate must score 40% in each section to pass in this paper.
- 3. A candidate will be declared pass in a paper on getting at least 40 marks. However to pass a year as a whole the aggregate marks should be 50% of the total marks for that year i.e. 200 out of 400.

4. If the student is declared unsuccessful on account of not scoring 50% aggregate marks in part-I or IInd year, as the case may be, but scored minimum passing 40% or above marks in each theory paper, he shall have freedom to re-appear in theory paper examination as he desires to settle the deficit or 50% aggregate marks to pass the examination in whole.

OR

The exemption in theory paper to unsuccessful examinees shall be granted on obtaining 50% marks in theory paper.

Ordinance No. 3 of 2014.

Examinations leading to the Post Graduate Diploma in Animation (Semester pattern, Two Year, Full Time) in the Faculty of Arts (Including Fine Art), Ordinance 2014.

Whereas, it is expedient to frame an Ordinance in respect of Examinations leading to the Post Graduate Diploma in Animation (Semester pattern, Two year, Full Time) in the Faculty of Arts Ordinance 2014, for the purposes hereinafter appearing, the Management Council is here by pleased to make the following Ordinance.

- 1) This Ordinances may be called "Examinations leading to the Post Graduate Diploma in Animation (Semester pattern, Two year Full Time) in the Faculty of Arts Ordinance 2013."
- 2) This Ordinance shall come in force with effect from the date of its approval by the Management Council.
- 3) Following shall be the examinations leading to the Graduate Diploma in Animation.
 - a) Post Graduate Diploma in Animation Semester I Examination
 - b) Post Graduate Diploma in Animation Semester II Examination
 - c) Post Graduate Diploma in Animation Semester III Examination
 - d) Post Graduate Diploma in Animation Semester IV Examination
- 4) Duration of the each semester will be of six months with an examination at the end of each semester. In semester IV there will be only internal assignments and grade A/B/C will be given. Also Project work will be assigned to the candidate and after internal and external evaluation, together, the grade will awarded.
- 5) (a) The examination specified in paragraph 3 above shall be held twice a year at such places and on such dates as may be fixed by the Board of Examinations.
 - (b) Main Examination of semester I and Semester III shall be held in winter and Supplementary Examination in subsequent Summer/Winter.
 - (c) Main Examination of Semester II and Semester IV shall be held in summer and Supplementary examination in subsequent Summer/Winter.
- 6) Subject to compliance with the provisions of this Ordinance and other Ordinances in force from time to time following candidates shall be eligible for admission to the Post Graduate Diploma in Animation (Semester pattern, Two year, Full Time) Graduates of any faculty of the University or of any statutory University equivalent thereto.
- 7) Subject to compliance with the provisions of this Ordinance and other Ordinances (Pertaining to examinations in general) in force from time to time, the applicant for admission to examination at the end of the course of study of a particular semester shall be eligible to appear at it, if:
 - a) The applicant Satisfied the conditions in the table and the provisions there under.

Note: Subjects prescribed and numbered in the scheme of examinations shall be treated as separate subjects; with theory and practical, and shall be treated as separate Head of Passing.

- b) The candidate has compiled with provisions of Ordinance pertaining to Examination in general.
- c) The candidate has prosecuted a regular course of study in University Department/College affiliated to the University.
- d) The candidate has in the opinion of the Head of the Department/Principal, shown satisfactory progress in the studies.
- 8) Papers and the practical in which an examinee is to be examined, maximum marks for these and the minimum passing marks which an examinee must obtain in order to pass in the subject and the examinations are detailed in the examination scheme appended herewith as Appendix-A with this Ordinance.
- 9) Examination fees for the semester of the examination and also the practical examination shall be as prescribed by the University from time to time.
- 10) Minimum passing marks for each theory and practical papers will be 50% separately.
- 11) An examinee who is successful at semester-I, Semester-II and Semester-III also must have completed assignments and project work as per the schedules given above for semester-IV examinations under this Ordinance and who obtained 75% or more marks in the aggregate of semester I, Semester II and semester III shall be placed in the first division with distinction, those obtaining 60% or more but less than 75% shall be placed in first division and all ohter successful examinees in the second division. (Division at the end of semester-IV shall be based on the aggregate of the marks obtained by the examinee in the semester-I, semester-II, semester-III and subject to completion of assignments and project work prescribed for semester-IV)
- 12) (a) Scope of the subjects shall be as indicated in the syllabus.
 - (b) Medium of instructions and examinations shall be English only.
- 13) Provision of Ordinance No.18 of 2001 relating to an Ordinance to provide grace marks for passing in a head of passing and improvement of division (higher class) and getting distinction in the subject and condonation of the deficiency of marks in subject in all the Faculties prescribed by the statute No.18, and of Ordinance No.10 relating to providing for exemptions and compartments shall apply to the examination under this Ordinance.
- 14) An examinee who dos not pass or who fails to present for the examination shall be eligible for readmission to the same examination on payment of fresh fees and such other fees as may be prescribed by the University time to time.
- 15) The merit list shall be notified as per Ordinance No.6
- 16) Notwithstanding anything to the contrary in this Ordinance no one shall be admitted to an course under this Ordinance, if candidate already passed the same examination or an equivalent examination of any Statutory University.
- 17) Examinees that have passed in all subjects prescribed for semester-I semester-II semester-III and have submitted the assignment, presentations and project work; for semester-IV of the examination course shall be eligible for award of the Post graduate Diploma in Animation.

ORDINANCE NO. 4 of 2014.

Examinations leading to the Post Graduate Diploma in Creative Writing in English (One Year) Course in the faculty of Arts, (Including Fine Art)

Whereas, it is expedient to make an Ordinance to provide for the examination leading to the Post Graduate Diploma in Creative Writing in English (One Year) course in the Faculty of Arts for the purpose hereinafter, the Management Council is here by pleased to make the following ordinance

- 1. This ordinance may be called "Examination leading to the Post Graduate Diploma in Creative Writing in English (One Year) course in the faculty of Arts Ordinance 2014."
- 2. This ordinance shall come in force with effect from the date of its approval by the Management Council.
- 3. The duration of the course shall be of one academic year.
- 4. The Examination leading to the Post Graduate Diploma in Creative Writing in English course shall be held annually at such place and on such dates as may be prescribed by the Board of Examinations.
- Subject to compliance of the candidate with the provisions of this Ordinance and any other Ordinance (Pertaining to Examination) in force from time to time, the candidates for admission to this examination shall have been obtained a Bachelor's degree in any faculty of this University or of any other statutory University whose degree is recognised as equivalent thereto by Sant Gadge Baba Amravati University.
- 6. The candidates may be admitted to this course in accordance with the rules of the University.
- 7. Without prejudice to the other provisions of Ordinance No. 6 relating to Examination in General, the provisions of paragraphs 5,8,10,27 and 32 of the said Ordinance shall apply to every collegiate candidate.
- 8. The fees for the examination shall be as prescribed by the University from time to time.
- 9. In order to pass the examination, an examinee shall obtain not less than 40% marks in each of the theory papers and project separately, and shall obtain not less than 50% in the aggregate marks in the examination. The candidate shall be given freedom to those as many subjects as directed for passing the examination in aggregate.
- 10. The scope of the subjects for examination shall be as indicated in the syllabus.
- 11. The scheme of examination for the course shall be as provide under **Appendix-A** appended with this Ordinance, and the examinee shall be examined in the subjects as indicated in the scheme of examination.
- 12. Successful examinees obtaining 75% or more marks in the aggregate but less than 75% at the examination shall be placed in the first division, while those obtaining less than 60% but not less than 50% marks in the second division.
- 13. Unsuccessful examinees at the above examination shall be eligible for admission to the next written and / or project examination on payment of fresh fees prescribed for the examination together with an ex-student fee. For being eligible for exemption in paper or project, the candidate must have obtained not less than 50% marks in the paper or project.
- 14. Provisions of Ordinance No. 18 of 2001 in respect of an Ordinance to provide grace marks for passing in a head of passing and improvement of division (Higher Class) and getting distinction in the subject and condonation of deficiency of marks in a subject in all the faculties prescribed by the Statute No. 18, and of Ordinance No. 10 relating to grant of exemptions and compartment shall be applicable to this course.

- 15. As soon as possible after the examination, the Board of Examinations shall publish a list of successful examinees. The list of examinees successful at examination shall be arranged in the First and Second divisions. The name of the examinees passing in the said examination in the minimum prescribed period be arranged in order of merit as per provisions of Ordinance No. 6
- 16. The examinees successful at the examination of the above P.G. Diploma course shall be awarded Diploma in the prescribed form signed by the Vice-Chancellor, on payment of the prescribed fees.
