1. Preamble

Under the Act, the previously mentioned reservation of 3 per cent seats in higher education institutes was expanded to 5 per cent for PWD. To initiate and regulate equal opportunities for differently-abled students across public universities in India, the University of Grants Commission (UGC) had in 2012, in compliance with the PWD Act, set up guidelines in the XIIth Plan. It is mandatory for all Universities and colleges to have an Equal Opportunities Cell (EOC).

2. Objectives

- To create awareness and provide guidance about various welfare schemes/ programmes/ fellowships/stipends offered by the Central /State governments for the welfare for the students belonging to these categories.
- To run various schemes funded by UGC, State and Central Government. For the underprivileged class students.
- To organize seminars /conferences/ workshop/ exhibitions/ cultural functions/sports events to increase social inclusion.
- To provide support and Assist students belonging to these categories and create barrier free access to various services
- To devise various measures to create socially conducive atmosphere in the university and establish redressel mechanism for grievance that may be reported by students.
