Subject: Procedure and Norms for grant of Continuation of Affiliation

to the Colleges & Continuation of Recognition to the

Institutions – Direction-2021

Ref: Direction No.16/2020, dated 12.10.2020 Published on 12/10/2020

Whereas, Maharashtra Public Universities Act-2016 has come into force with effect from 1st March, 2017.

AND

Whereas, Sections 5(24),(28) & (29) of Maharashtra Public Universities Act 2016 prescribes powers and duties of University to lay down conditions, monitor & evaluate and to inspect and Sections 110,111 &114 of Chapter-X provides the procedure for regarding grant of Affiliation / Recognition and Continuation of Affiliation to the Colleges & Institutions.

AND

Whereas, Section 37(1)(j) of Maharashtra Public Universities Act 2016 provides to conduct Academic Audit and Section 37(1)(k) provides to oversee Continuation of Affiliation to Colleges & Continuation of Recognition to Institutions through a system of Academic Audit.

AND

Whereas, clause (m) of Sub-section (1) of Section 33 of Maharashtra Public Universities Act-2016, provides that the Academic Council shall prescribe the norms for granting Affiliation, Continuation of Affiliation, Extension of Affiliation to Colleges, and Recognition, Continuation of Recognition, Extension of Recognition to Institutions of higher learning and research of Specialised Studies.

AND

Whereas, the Academic Council in its meeting held on dated 22.12.97 vide Item No.30 in considering the recommendation of the Committee No.3/1997 has prescribed norms for grant of Affiliation, Continuation of Affiliation, Extension of Affiliation & Recognition to the Colleges / Institutions under the Provision of Sections -83, 84, 86 & 87 of Chapter-X of the then Maharashtra Universities Act-1994, which were issued vide Direction No.4/1998 dt. 27.10.1998, u/s 14(8) of the then Act.

AND

Whereas, as per Section 37(1)(k) of Maharashtra Public Universities Act, 2016, the continuation of affiliation / Recognition to the Colleges/ Institutions shall be through a system of academic audit, thereafter it shall be granted u/s 114 of the Act, for which legislation is required.

AND

Whereas, in view of above, the Board of Deans in its meeting held on 27^{th} April, 2019 vide Item No.30, has prepared the norms and procedure for grant of continuation of affiliation to colleges/ Institutions under the provisions of Section 37(1)(j) for the purpose of Section 37(1)(k) of the Act, and recommended the same to the Academic Council.

Whereas, the Academic Council in its meeting held on 30.4.2019 vide Item No.8 has accepted the Procedure & Norms u/s 33(1)(m) of the Act, as recommended by the Board of Deans.

AND

Whereas, the matter pertains to Section 71(18) of the Act and is to be regulated by prescribing Statute as required u/s 72 of Maharashtra Public Universities Act, 2016 which is time consuming process, and with a view to initiate action, to implement the Procedure & Norms the Hon'ble Vice-Chancellor in exercise of powers vested in him u/s 12(7) of the Act, has approved the Procedure & Norms of Academic Audit for grant of Continuation of Affiliation to the colleges or institutions (महाविद्यालय/संस्थाच्या संलिग्निकरण चालु ठेवण्याकरीता विद्याविषयक लेखा परिक्षणाची मानके व कार्यप्रणाली) as accepted by the Academic Council, on behalf of Management Council and the Senate.

AND

Whereas, thereafter the Direction No.15/2019 has been issued u/s12(8) of the Act, and the Management Council has approved the said Direction vide Item No.147 in its meeting held on 23 Oct., 2019 and the Senate has also approved the same in its meeting held on 6/9 March, 2020

AND

Whereas, as per Section 12(8) of the Act, the Direction lapses automatically on completion of 6 months period, if the Statute, Ordinance or Regulation, as the case may be, could not be prescribed therefor, as per which the Direction No.5/2020 referred above was lapsed, hence the Direction No.16/2020 dated 12/10/2020 has been issued. This Direction is also going to be lapsed now, on completion of 6 months period.

AND

Whereas, as the matter of continuation of affiliation is to be regulated by Statute and framing thereof u/s 72 of the Act is under process, in response to the resolution of Management Council vide Item No.147 mentioned above, to place before the Statute Committee, but due to COVID-19 pandemic the office workings are affected and work of academic audit is also suffered.

AND

Whereas, as per Norms – Para – 8, the formation of Academic Audit Committees and completion of audit could not be done by 2^{nd} week of March, 2021, due to COVID-19 Pandemic, which requires extension in time till 31^{st} May, 2021, but this extension shall be only for the academic session 2021-22.

Therefore, I, Dr. Murlidhar Chandekar, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of powers vested in me vide Sub-Section (8) of Section-12 of Maharashtra Public Universities Act, 2016 hereby issue the following Direction, afresh, so as to keep the norms of the Direction No.5/2020 and 16/2020 in continuation and in force.

- 1. This Direction may be called "Procedure and Norms for grant of Continuation of Affiliation to the colleges & Continuation of Recognition to the Institutions"- Direction 2021.
- 2. This Direction shall come into force from the date of its issuance and, grant of continuation of affiliation / Recognition u/s 114 of the Act, through a system of academic audit as per Section 37(1)(k) of the Act, to the Colleges/ Institutions shall be from the Academic Session 2021-2022.
- 3. Procedure and Norms for grant of Continuation of Affiliation to the colleges & Continuation of Recognition to the Institutions shall be as per Appendix-I appended to this Direction, with the illustration regarding 'other officers of the University' prescribed in Para-8 of the Norms, which shall be as Deans of Faculties, Director of Innovation, Incubation & Linkages, Director of Knowledge Resource Center, Director of Life-long Learning & Extension and Director of Sports & Physical Education.

- 4. Further, the formation of Academic Audit Committees & carrying out academic Audit shall be completed upto 31st May, 2021 instead of 2nd week of March (Para-8 of the Norms), but this extension in period shall be for the academic session 2021-22 only.
- 5. The Direction No. 16/2020 stands repealed.
- 6. COVID-19 Pandemic Circumtances / atmosphere is still not over, the change if any, in future, shall be communicated by Notification by the University.

Appendix-I

Procedure and norms of Academic Audit for grant of Contination of Affiliation to the colleges or institutions.

- A Management of the college/institution or Principal shall apply for continuation of affiliation or continuation of recognition as the case may be, to the Registrar Sant Gadge Baba Amravati University, Amravati in prescribed application form by online mode along with the fees prescribed from time to time, upto the last date notified by the university by Notification in Gazette Part-II. The application fee is not refundable.
- 2) Every college/institute which is already affiliated to or recognized by the University, shall pay annual affiliation/recognition fees as prescribed by the University from time to time, in favour of the Finance & Accounts Officer, Sant Gadge Baba Amravati University, Amravati before the last date as Notified, for the submission of Application form.
- 3) For Professional Courses, approval/permission from respective Statutory Apex bodies / Council shall be mandatory, which must be obtained by the Trust / Society /Management / Principal of the college/Institute.
- Each application form for the continuation of affiliation/recognition should be accompanied by a report to be prepared and submitted by the Principal / Head of the college/institute about the general information, of Trust / Society, College / Institute, statutory compliances, physical and academic infrastructure & assets, program / course curriculum, teaching-learning processes academic progress, outcomes and administrative and financial position of the college for the previous year, as required for part I to part VI of Academic Audit Report which is conducted u/s 37(1)(j) of Maharashtra Public Universities Act 2016. Terms & Condition given by the earlier Enquiry Committee & compliance thereof shall also be submitted, in Academic Audit Report.
- The application must provide all the necessary information and it should be complete in all respects. All information provided in the application should be factual and verifiable. Application forms must accompany all enclosures and other information necessary for the purpose of continuation of affiliation/recognition.
- After receipt of applications in stipulated time, Board of Deans u/s 37(1)(j) of the Act will carry out academic audit of colleges/institutions, as the case may be, by an Academic Audit committee, for the purpose of clause(k) of the said Section of the Act.

- 'Academic Audit Committee' means 'the committee constituted by the university for the purpose of academic audit having an equal number of internal and external members'. 'Internal members' means 'the members appointed by College/Institute from the pool of experts generated by the university'. 'External members' means 'those who are not internal members but appointed by the university from the pool of experts'. Pool of experts will be formed by the university. The Chairman of the Committee shall be from the external members so appointed.
- 8) The pool of experts will be the congregation of nominations of teachers who are members of Senate, Management Council, Academic Council, other officers of the university, approved Principals, I.Q.A.C. and NAAC / NBA Coordinators of the colleges/institutes, Professors, Associate Professors who have undergone "Academic Audit Awareness Program" organized by the university as well as Assistant Professors, Librarians, Directors of Physical Education & Sports with Ph.D. & with minimum 10 years of experience, non teaching staff not below the rank of Head Clerk with minimum 15 years of experience & have successfully completed the training program / workshop organized for Academic Auditors by the University for the said purpose. Formation of Academic Audit Committees & carrying out academic audit should be completed during the period from third week of October to Second week of March for the applicant colleges/institutions for continuation of affiliation / recognition. The Principal shall be informed accordingly before 7 days of scheduled visit of the Committee. The committee shall prepare a report, containing its observations, evaluation & recommendations and submit the same to the University online and hard copy of the same duly signed by the chairman and all the members of the Committee within 7 days of its completion of audit.
- 9) The Academic Audit/Inspection Committee will carry out the audit/inspection as per the norms given in the Part I to VI and manual of Academic Audit Report.
- 10) It shall be the duty of the Management / Society or the Principal to receive the Academic Audit Committee and to provide all the necessary information as desired and demanded by the committee.
- The Management should not admit the students unless the Continuation of Affiliation/Recognition is granted to the college/institution. The University will not be responsible for any consequences, if the students are admitted without grant of continuation of affiliation / recognition.
- The Management whose college or institution has been granted affiliation or recognition, shall give the undertaking to comply with the conditions mentioned in Section 108 (a) to (k) Maharashtra Public Universities Act, 2016.
- The affiliation accorded to a college/institution may be withdrawn by the University as per the procedure laid down in Section 120 of Maharashtra Public Universities Act, 2016. If the University finds that the college/institution has not complied with the provision of Section 108 (a) to (k) or the college/institute has failed to act according to the directions given by the University from time to time, the erring colleges / institutions may be penalised by imposing the penalty as per procedure prescribed and have to pay the penalty to the University as prescribed, in case of non-compliance or found failure in providing information, etc. desired by the University.
- 14) The University will organize 'Academic Audit Awareness Program' and Workshops for eligible experts as and when required to form / modify pool of experts for Academic Audit. The Board of Deans shall approve the Pool of Experts for the purpose of Academic Audit.
