Whereas, the Academic Council in its meeting held on 17.02.2014 vide item No. 24 has accepted the promotion scheme for Pharm.D. course Part-I to VI.

AND

Whereas, the promotion scheme for Pharm.D. course is required to be regulated by framing the Ordinance.

AND

Whereas, the Academic Council has resolved to refer the matter to Ordinance Committee.

AND

Whereas, making of an Ordinance for Pharm.D. course may likely to take some time.

AND

Whereas, the promotion scheme for Pharm.D. course is to be implemented from the Session 2014-15.

AND

Whereas, the Academic Session 2014-15 is commencing from June-2014.

Now, therefore, I, Dr.J.A.Tidke, Vice Chancellor, Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under sub-section (8) of Section 14 of the Maharashtra Universities Act., 1994, do hereby direct as under:

- This Direction may be called "Corrigendum to Direction No.2 of 2012 in respect of Examinations Leading to the 1) Degree of Pharm.D. (Doctor of Pharmacy) Direction, 2014"
- This Direction shall come into force from the date of its issuance.
- Following shall be the promotion scheme for Pharm.D. (Doctor of Pharmacy) Part I to Part-VI.
