Subject: Repealing of Direction No.26/2004, dt.1.7.2004 on Admission of Students in affiliated Colleges/ University Teaching Departments by courses and late admission with the permission of Hon'ble Vice-Chancellor, under Ordinance No.2, 'Direction-2021'

Whereas, the Original Ordinanace No.2 prescribes procedure for Admission of Students to the courses in the affiliated Colleges / Teaching Departments of the University and as per its para-3 the last date for admission by the colleges / Department is upto first Monday in August of the Academic Year.

AND

Whereas, the first proviso of para -3 of the above said Ordinance provides that -the Vice-Chancellor may permit Colleges / University Teaching Departments to grant admission to Colleges / University Teaching Departments in a session late upto one month after the First Monday in August, i.e. after the last date prescribed for admission.ø But in view of decision of Academic Council it was extended by two months vide Direction No.26/2004, and the Ordinance No.2 is yet to be amended.

AND

Whereas, the Academic Council in its meeting held on 6th June, 2017 vide item No.57 resolved to keep the last date of admission with the permission of Honøble Vice-Chancellor upto one month instead of two months, as some examinations were to be conducted at colleges level but subsequently it was found difficult, hence it was discontinued, so also almost all the examinations are being conducted on semester pattern instead of Annual pattern.

AND

Whereas, as the matter is related to the Ordinance, it has been placed before the Board of Deans, vide Item No.22 in its meeting held on 18.3.2020, which has recommended to Academic Council to repeal the Direction No.26/2004, which provides two months time.

AND

Whereas, the Academic Council in its meeting held on 4.12.2020 vide Item No.63 has accepted the recommendations of Board of Deans as mentioned above.

AND

Whereas, the matter is relating to Original provision of the original Ordinance No.2 to its para-3 first proviso, which will be automatically remain intact, if the Direction No. 26/2004 is repealed.

Therefore, I, Dr. Murlidhar Chandekar, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise the powers vested in me, under the provisions of sub-Section (8) of Section-12 of Maharashtra Public Universities Act, 2016, issue the following Direction:

- 1. This Direction may be called ÷Repealing of Direction No.26/2004, dt.1.7.2004 on Admission of Students in affiliated Colleges/ University Teaching Departments by courses and late admission with the permission of Honøble Vice-Chancellor, under Ordinance No.2, Direction-2021.ø
- 2. This Direction shall come into force from the date of its issuance.
- 3. As the first proviso of Original para-3 of Original Ordinance No.2 is not yet amended by prescribing an Ordinance with reference to Directin No.26/2004, the original provision of one month shall automatically remain intact and it shall be followed. Consequently the Direction No. 26/2004 stands repealed as per decision of the Academic Council. By this the last date of admission with the permission of the Vice-Chancellor shall be upto one month from the day of first Monday of August of that academic year.
