### Direction No. 3 /2014

Subject: Educational Qualifications, Pay Scale, Services and the procedure of Selection, etc in respect of the post of Director, Adult Continuing Education and Extension Services in the University.

Whereas, the Government of Maharashtra has accorded approval to create and fill up the statutory post of Director, Adult and Continuing Education and Extension Services, in the University Establishment as laid down under section 22 of the Maharashtra Universities Act, 1994 vide G.R.No.संकिर्ण 2010/(309/10)/ विशि -1,dt.27.12.2013, in the pay structure of Rs.37400-67000/- Payband Rs.10,000/- AGP alongwith specified Educational Qualification,

#### AND

Whereas, the Management Council of the University has been empowered under section 28(r) of the Maharashtra Universities Act, 1994 to lay down by the Statute on the basis of qualification and terms and conditions of service and the guidelines approved by the State Government from time to time, and the procedure of appointment of university teachers and non-vacational academic staff and fix their emoluments and norms of workload and conduct and discipline,

### AND

Whereas, the Management Council of the University in its meeting dt.23.1.2014 vide Item No.5 noted the above Government Resolution dt.27.12.2013 and approved the particulars of the Educational Qualifications, pay scale, Terms and Conditions of Service and procedure of Selection etc. to be laid down by the Statute in respect of the post of Director, Adult and Continuing Education and extension services in the University,

#### AND

Whereas, it is expedient to prescribe the Educational qualification, pay scale, services and the procedure of selection etc. in respect of the post of Director, Adult and Continuing Education and extension services in the University,

### AND

Whereas, the matter is to be regulated by making suitable Statute, which will take some time to prescribe,

## AND

Whereas, the process of recruitment of the post of Director, Adult and Continuing Education and extension services is to be initiated,

Now, therefore, I, Dr.Jaikiran A Tidke, Acting Vice-Chancellor, Sant Gadge Baba Amravati University in exercise of powers conferred upon me as per Sub-section (8) of Section 14 of the Maharashtra Universities Act, 1994 issue the following Direction to prescribe the Educational Qualifications, Pay Scale, Terms & Conditions of Services and the procedure of Selection, etc for the post of Director, Adult and Continuing Education and Extension Services in the University, till such time, the Statute comes into force.

This Direction may be called "the Direction to prescribe the Educational Qualifications, Pay Scale, Terms & Conditions of Services and the procedure of Selection, etc for the post of Director, Adult and Continuing Education and Extension Services in the University, 2014".

This Direction shall come into force from the date of its issuance.

1) The Director of Adult and Continuing Education and Extension Services shall be appointed by the Vice Chancellor on the recommendations of Selection Committee constituted under section 22(1) of the Maharashtra Universities Act,1994.

The Director shall be appointed in the first instance on probation for a period of two years. On the expiry of the said period and on his having completed the probationary period satisfactorily, may be confirmed by the Appointing Authority. It shall, however, be competent for the Appointing Authority and the Director of Adult and Continuing Education and Extension Services at any time during the period of probation or thereafter, by either side giving one calendar months'notice in writing to the other or by mutual agreement, to terminate the tenure of his office.

- The Director of Adult and Continuing Education and Extension Services shall have the powers and duties as prescribed under the provisions of the Maharashtra Universities Act,1994. He shall also perform such other duties as may be assigned to him by the Vice Chancellor.
- 3) a) The age of the candidate applying for the post of Director of Adult and Continuing Education and Extension Services shall not be less than 45 years.
  - Provided, however, that in respect of the employees in service of any University, College or Recognised Institution, the minimum age limit may be relaxed.
  - b) The age of retirement of the Director of Adult and Continuing Education and Extension Services shall be sixty years.
- 4) The pay structure for the post of Director of Adult and Continuing Education and Extension Services shall be in the pay band of Rs. 37400-67000 with AGP Rs.10,000/- as prescribed by the Government of Maharashtra and as revised by the State Govt. from time to time. He shall also be entitled to such allowances as are admissible to other academic staff of the University.
- 5) The Director of Adult and Continuing Education and Extension Services shall be appointed by inviting the applications by an advertisement in important News Papers. The minimum qualifications for the post of the Director of Adult and Continuing Education and Extension Services shall be as under:-
  - (i) Ph.D. in any discipline.
  - (ii) Evidence of published work with minimum of 10 publications as research papers and or books/policy papers.
  - (iii) A minimum of ten years teaching experience in University/College, and/or experience in research at the University/National level institutions/industries, including experience of guiding candidates for research at doctoral level.
  - (iv) Contribution to educational innovation, design of new curricula and courses, and technology mediated teaching learning process.
  - (v) A minimum score as stipulated in the Academic Performance Indicator(API) based Performance Based Appraisal Systems(PBAS) set out in Appendix-III of the U.G.C.Regulation-2010.
  - (vi) Experience of activities like Students Welfare/N S S/ Adult Education at College/ University level.

OR

An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/allied relevant discipline to be substantiated by credentials.

## 6) Procedure of selection:

a) The date of the meeting of Selection Committee shall be so fixed so as to allow notice of atleast thirty clear days to each member of the Selection Committee and to the candidates.

- b) The quorum to constitute the meeting of the Selection Committee shall be at least three members of whom atleast one shall be a person each nominated under subclause (c) and clause (d) of sub-section 1 of section 22 of the Maharashtra Universities Act,1994.
- c) The Selection Committee shall interview, adjudge the merits of each candidate in accordance with the qualifications advertised and report to the appointing authority the names arranged in order of merit of the persons whom it recommends for appointment to the post of the Director of Adult and Continuing Education and Extension Services.
- d) The appointing authority shall appoint the Director of Adult and Continuing Education and Extension Services on the recommendations of the selection committee.

Provided that whenever the appointing authority proposes to make an appointment otherwise than in accordance with the order of merit arranged by the selection committee, it shall record its reasons in writing.

The Director of Adult and Continuing Education and Extension Services shall be entitled to all benefits available to the University Non Vacational Academic Staff and his services shall be governed by the provisions of Maharashtra Universities Act, 1994, Relevant Satutes, Ordinances, Rules & Regulations, Directions etc. of the University in force and as prescribed from time to time.
