Whereas, Ordinance No.1 of 2016 for award of Degree of Doctor of Philosophy (Ph.D.) , Recognition of Supervisor and Research Center in all Faculties in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D.Degrees) Regulations, 2016 is in existence in the University.

AND

Whereas, as per the provisions of Ordinance No.1 of 2016 the eligible candidate shall apply to the research center (RC) for admission to the Ph.D.Programme in the prescribed format on or before 1st December every year.

AND

Whereas, as per the provisions of Ordinance No.1 of 2016 after the interview process the selected candidate shall confirm the admission by paying the prescribed fees and depositing essential original documents on or before 31st December of the year.

AND

Whereas, the result of the Ph.D. Entrance Test (PET) Special Examination was declared on 10th September 2018 and the actual implementation of the process of Ph.D. programme has been started from the month of September.

AND

Whereas, as per the provision of Ordinance No.1 of 2016 the process includes the declaration of subject wise seats for admission, criteria and procedure for admission and all other relevant information on the University website.

AND

Whereas, in view of above process and to facilitate the scholar for availability of new supervisors and research centers for accommodation of maximum scholars to the Ph.D. Programme. The process to notify new supervisors and declaration of the list of additional recognized research centers will last till 10th March 2019, hence the extension of dates as mentioned in Ordinance No.1 of 2016 is necessary for this year only.

AND

Whereas, making amendment to an Ordinance is time consuming process.

Now, therefore, I, Dr.Murlidhar Chandekar, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016 hereby direct as under:-

- 1. This direction may be called "Extension of dates for admission to the Ph.D.Programme."
- 2. This direction shall come into force from the date of its issuance.
- 3. In Part-C-2 of Ordinance No.1 of 2016 following transitory provision be added –

"To ensure the proper implementation of the process of Ph.D. admission to the Ph.D. programme as per this Ordinance, the Vice-Chancellor of the University is empowered to change the dates mentioned in the provision of Ordinance No.1 of 2016 for this year only."

Center in all Faculties in accordance with the University Grants

Commission (Minimum Standards and Procedure for Award of
M.Phil./Ph.D.Degrees) Regulations, 2016.

Whereas, Ordinance No.1 of 2016 for award of Degree of Doctor of Philosophy (Ph.D.) , Recognition of Supervisor and Research Center in all Faculties in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D.Degrees)Regulations, 2016 is in existence in the University.

AND

Whereas, as per the provisions of Maharashtra Public Universities Act, 2016 the nomenclature of the faculties has been changed and accordingly the changes in the name of the faculty in Ordinance No.1 of 2016 need to be changed.

AND

Whereas, as per the provisions of Maharashtra Public Universities Act, 2016 the nomenclature of the authorities has been changed and accordingly the changes in the name of the authority mentioned in Ordinance No.1 of 2016 need to be changed.

AND

Whereas, Clause 7.6 of University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D Degrees) Regulations, 2016 {In supersession of the UGC (Minimum Standards and Procedure for Awards of M.Phil./Ph.D. Degree) Regulation, 2009, notified in The Gazette of India [No. 28, Part III- Section 4] for the week July 11-July 17, 2009}, provided as follows-

"Candidates already holding M. Phil. degree and admitted to the Ph.D. programme, or those who have already completed the course work in M.Phil. and have been permitted to proceed to the Ph.D. in integrated course, may be exempted by the Department from the Ph.D. course work. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. course work prescribed by the Department."

AND

Whereas, the process of declaration of result for award of Ph.D. degree for the candidates registered under the previous Ordinance/s is a time consuming process and takes time to issue the Notification for award of the Ph.D. degree.

AND

Whereas, making amendment to an Ordinance is time consuming process.

Now, therefore, I, Dr.Murlidhar Chandekar, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me under sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016 hereby direct as under:-

- 1. This direction may be called "Amendment/s to Ordinance No.1 of 2016 for award of Degree of Doctor of Philosophy (Ph.D.), Recognition of Supervisor and Research Center in all Faculties in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D.Degrees) Regulations, 2016.
- 2. This direction shall come into force from the date of its issuance.
- 3. Clause 3 of Ordinance No.1 of 2016 be read as-

"The Ordinance is applicable to the following faculties-

- 1) Faculty of Science & Technology
- 2) Faculty of Commerce & Management
- 3) Faculty of Humanities
- 4) Faculty of Inter-disciplinary Studies"
- 4. The Number "(I)" be added before the word "A teacher" in the second para of clause A-1 of PART-A of the Ordinance,
- 5. The following Para- (II) be added after the word and sign "publications" in sub-clause (b) of clause (v) of PART-A of the ordinance.
 - "(II) A Research Scientist working in the Recognised Research and other Institutions seeking Recognition as a Ph.D. Supervisor shall submit the application in the prescribed form (Appendix-1) along with non-refundable fees as prescribed by the University from time to time on or before 31st August every year and shall satisfy the following conditions:
 - i) Must possess Master's Degree in the relevant / interdisciplinary subject.
 - ii) Must have Ph.D. in the relevant subject in which recognition is sought.
 - iii) Must have at least Ten years experience in Research and Development laboratories or centres in variety of Industries.
 - iv) Must have atleast two Research Publication in the concerned subject in the refereed journals after award of Ph.D. Degree.
- 6. The words "along with Admission Processing Fees" be added after the word "format" and before the word "on" in the first para after the sub-clause (b) of Clause B-2.2.
- 7. The words "course work" be added after the word "prescribed" and before the word "fees" in the last Para in sub-clause b) of Clause B-2.2.
- 8. The words and sign "(as per the Appendix-5(B))" be added after the word "documents" and before the word "on" in the last para in sub-clause b) of Clause B-2.2.
- 9. The sentence "The list of the admitted candidates along with the Corse Work enrolment form (Appendix-5(A)) and Course work Enrollment Fees should be submitted within the 10 Days to the University" be added after the last Para of the sub-clause b) of Clause B-2.2.
- 10. The word "BUTR" wherever appeared be replaced by the words "Board of Deans"
- 11. The word and sign "(as per UGC Regulation 2009)" in the second para of Clause B-2.3 of PART-B of the Ordinance be deleted and the words "from the Recognized University" be added after the word "M.Phil." and before the word "shall"
- 12. The word "Board of Examination (BoE)" be replaced by the words "the Vice-Chancellor" in Third and Fourth Para in Clause B-5.
- 13. The sentence "however the date of final submission of the thesis shall be treated as the date of award of Ph.D. Degree" be deleted in fifth Para of Clause B-5.1. The sign "." be added after the word "thesis" in the same para.
- 14. The last sentence "The Ph.D. degree shall be conferred on the candidate in the ensuing convocation of the University" of the Clause B-5.1 be deleted.
- 15.In the Transitory Provisions Clause 2.4 of PART-C of Ordinance, the sentence "and the process of Declaration of result of Ph.D. on receipt of the favorable report on the defense of the thesis" be added after the word "thesis"
