Examinations leading to the Degree of (समाजकार्य स्नातक) Bachelor of Social Work (Three Year Degree Course) (Amendment) Ordinance, 2015.

Whereas, it is expedient to further amend the Ordinance in respect of "Examinations leading to the Degree of (समाजकार्य स्नातक) Bachelor of Social Work (Three Year Degree Course) i.e. original Ordinance No.136" for the purposes hereinafter appearing, the Management Council is hereby pleased to make the following Ordinance.

- 1 This Ordinance may be called "Examinations leading to the Degree of (समाजकार्य स्नातक) Bachelor of Social Work (Three Year Degree Course) (Amendment) Ordinance, 2015".
- 2. This Ordinance shall come into force with effect from the date of its approval by the Management Council.
- 3. i) In para 2 of the Original Ordinance i.e. Ordinance No. 136 in respect of Examinations leading to the Degree of (समाजकार्य स्नातक) Bachelor of Social Work (Three Year Degree Course) (hereinafter referred to as the main Ordinance) the words 'Academic Council' be substituted by the words "Board of Examinations".
  - ii) Para 8 of the main Ordinance i.e. Ordinance No. 136 be substituted by "The fees for the examination shall be as prescribed by the University from time to time.
  - iii). Para 17 of the main Ordinance i.e. Ordinance No.136 be substituted as under :-
    - "17. Provisions of Ordinance No.18 of 2001 relating to an Ordinance to provide grace marks for passing in a head of passing and improvement of Division (Higher Class) and getting distinction in the subject and condonation of deficiency of marks in a subject in all the faculties prescribed by the Statute No.18, Ordinance, 2001 and the Ordinance No.10 relating to provide for Exemptions and Compartments shall apply to the examination under this Ordinance".
  - iv) In para 19 of the main Ordinance i.e. Ordinance No. 136, the words "but not later than the 30<sup>th</sup> June next following in case of the examinations held in March-April and 28<sup>th</sup> February next following in case of the examinations held in October-November, the Executive Council", be substituted by the words "the Board of Examinations U/S 72 of Maharashtra Universities Act, 1994,"

#### Ordinance No. 10 of 2015

Examinations leading to the Degree of Bachelor of Journalism and Mass Communication (B.J.M.C.) (Annual Pattern - Three Years Degree Course) Ordinance, 2015.

Whereas, it is expedient to make an Ordinance for examinations leading to the Degree of Bachelor of Journalism and Mass Communication (B.J.M.C.) Annual Pattern - Three Year Degree Course in the faculty of Social Sciences, for the purpose hereinafter appearing the Management Council is hereby pleased to make the following Ordinance :

- 1. This Ordinance may be called, "Examinations leading to the degree of Bachelor of Journalism and Mass Communication (B.J.M.C.) Annual Pattern Three Year degree course Ordinance, 2015".
- 2 This Ordinance shall come into force from the date of its passing by the Management Council.
- 3. The following shall be the examinations Leading to the Degree of Bachelor of Journalism and Mass Communication Annual Pattern Three Year Degree Course namely:
  - i) Bachelor of Journalism and Mass Communication Part-I Examination
  - ii) Bachelor of Journalism and Mass Communication Part-II Examination
  - iii) Bachelor of Journalism and Mass Communication Part-III Examination.
- 4. The Examinations leading to the Degree of Bachelor of Journalism and Mass Communication (B.J.M.C.), Annual Pattern Three Years Degree Course shall be held twice a year at such places and on such dates as may be appointed by the Board of examination.
- 5. Subject to his/her compliance with the provisions of this Ordinance and of other Ordinances in force from time to time, a candidate shall be admitted to the Examination provided that he/she has passed the Higher Secondary School Certificate Examination of any Statutory Board and its equivalent thereto.
- 6. The fees for the examinations shall be as prescribed by the University from time to time.

- 7. The Examinations shall consist of subjects as indicated in the scheme of Examinations as per Appendix-'A' appended to this Ordinance.
- 8. The provisions of Original Ordinance No. 10 relating to Examinations and compartments shall apply to the examinations under this Ordinance.
- 9. (a) The scope of the subjects shall be as indicated in the syllabi.
  - (b) The medium of instruction and Examination shall be English/Marathi/Hindi except for the subject in languages. The Question paper shall be in English/Marathi/Hindi.
- 10. The maximum marks allotted for each subject/paper/practical and the minimum marks to pass the examinations as prescribed in **Appendix 'A'** appended herewith.
- 11. An unsuccessful examinee may appeared for the examinations in that subject at a subsequent examination on payment of a fresh fee and such other fees as may be prescribed by the University from time to time.

Provided that an examinee who fails in practical examination of subject may appeared again for the examination in practical subject.

Provided further that an examinee who fails in the practical Class Work of Subject may appeared again for appeared in Class work subject before the Head of the Deptt. of Mass Communication in the concerned Institution.

- 12. Successful examinees obtaining not less than 60% marks in the aggregate shall be placed in the First Division, those obtaining less than 60% but not less that 50% marks in the aggregate in the second division and all other successful examinees securing minimum 40% marks in the Third Division.
- 13. The provision of Ordinance 18 of 2001 relating to an Ordinance to provide grace marks for passing in a Head of passing and Improvement of Division (Higher Class) and getting distinction in the subject and condonation of Deficiency of Marks in a subject in all the faculties prescribed by the Statute No.18, shall apply to the examinations under this Ordinance.
- 14. As soon as possible after the examination, the Board of Examinations shall publish a list of successful examinees arranged in three Divisions. The names of the examinee passing the examination in the minimum prescribed period and obtaining the prescribed number of places in the first or second divisions shall be arranged in order of Merit as provided in the examinations in general Ordinance No.6
- 15. Notwithstanding anything to the contrary in this Ordinance no person shall be admitted to an examination under this Ordinance if, he/she has already passed the same or an equivalent examination of any other statutory University.
- 16. Successful examinees shall, on payment of the prescribed fees, will receive a degree in the prescribed form signed by the Vice-Chancellor.
- 17. The provisions of Ordinance No. 42 of 2005 relating to the examination in Environmental Studies leading to Bachelor Degree are applicable for second year of this course.
- 18. The provisions made under the Ordinance in respect of Examination leading to the degree of Bachelor of Mass Communication i.e. Ordinance No. 13 of 2000, shall stands repealed.

# Examinations leading to the Degree of Master of Journalism and Mass Communication (M.J.M.C.) (Semester - Pattern Two Years Degree Course) Ordinance, 2015.

Whereas, it is expedient to make an Ordinance for examinations leading to the Degree of Master of Journalism and Mass Communication (M.J.M.C.) Semester Pattern - Two Year Degree Course in the faculty of Social Sciences, for the purpose hereinafter appearing the Management Council is hereby pleased to make the following Ordinance:

- 1. This Ordinance may be called, "Examinations leading to the degree of Master of Journalism and Mass Communication (M.J.M.C.) Semester Pattern Two Year degree course Ordinance, 2015".
- 2 This Ordinance shall come into force from the date of its passing by the Management Council.
- 3. The following shall be examinations Leading to the Degree of Master of Journalism and Mass Communication Semester Pattern Two Year degree course namely:
  - i) Master of Journalism and Mass Communication Semester-I Examination,
  - ii) Master of Journalism and Mass Communication Semester-II Examination,
  - iii) Master of Journalism and Mass Communication Semester-III Examination and
  - iv) Master of Journalism and Mass Communication Semester-IV Examination.
- 4. The Examinations leading to the Degree of Master of Journalism and Mass Communication (M.J.M.C.) Semester Pattern Two Years degree course shall be held at the end of each semester on such dates as may be appointed by the Board of examinations.
- 5. Subject to his/her compliance with the provisions of this Ordinance and of other Ordinances in force from time to time, a candidate shall be admitted to the Examinations provided he/she has prosecuted a regular course of study and fulfilled the requirement of the relevant Ordinances in the University Department of Mass Communication or the Colleges affiliated to the University.
- 6. The fees for the examination shall be as prescribed by the University from time to time.

- 7. The Examinations shall consist of 4 semester programmes for Master of Journalism and Mass Communication (M.J.M.C..) Semester Pattern Two Year Course. This may be termed as Semester Pattern I, II, III and semester IV in continuation for those who are admitted in the course after completing any bachelor degree or Three years Bachelor of Journalism & Mass Communication. The student who have passed one year post graduate degree course in Journalism &/or Mass Communication e.g. B.M.C., B.J. only from Sant Gadge Baba Amravati University will be eligible to take admission in semester III of M.J.M.C.. The Division will be awarded on the basis of combined score in B.M.C., B.J. degree and IIIrd & IVth semester of M.J.M.C. combined. However, for regular M.J.M.C. students, combined score of all four semesters will be the basis of award of division.
- 8. Subject to his/her compliance with the provisions of this ordinance and other ordinances (Pertaining to Examination in General) in force from time to time the applicant for admission, at the end of the course of study of a particular semester to an examination specified in column (2) of the table below shall be eligible to appear at it, if:
  - i) he/she satisfied the condition in the table and provisions there under.
  - ii) he/she has prosecuted a regular course of study in a college affiliated to the university.

- 9. It is essential to clear all the semesters for being declared successful in the Master of Journalism and Mass Communication (M.J.M.C.) Semester Pattern Two Year Degree Course examinations.
- 10. (i) The Scope of the subjects shall be as indicated in the syllabus.
  - (ii) The medium of instructions and examinations shall be English/Marathi/Hindi. The Question Paper will be set in English/Marathi/Hindi.
- 11. The maximum marks allotted for each subject/paper shall carry and the minimum marks which an examinee must obtain in order to pass the examinations shall be as indicated in **Appendix-A**.
- 12. An examinee unsuccessful in a subject may present him for the examination in that subject at a subsequent examination on payment of a fresh fee and such other fees as may be prescribed.
  - Provided that an examinee who fails in practical examination may present himself again for the examination in practical subject only.
- 13. The date for submission of Synopsis and Dissertation to the University shall be as prescribed by the University from time to time.
- 14. Successful examinees obtaining not less than 60% marks in the aggregate shall be placed in the First Division, those obtaining less than 60% but not less that 50% marks in the aggregate in the second division and all other successful examinees securing minimum 40% marks in the Third Division.
- 15. Every examinee must pass in each subject of each semester separately and secure minimum 40% marks in each subject.
- 16. The provision of Ordinance 18 of 2001 relating to an ordinance to provide grace marks for passing in a Head of passing and Improvement of Division (Higher Class) and getting distinction in the subject and condonation of Deficiency of Marks in a subject in all the faculties prescribed by the Statute No.18 shall apply to the examinations under this ordinance.

- 18. Notwithstanding anything to the contrary in this direction no person shall be admitted to an examination under this direction if, he/she has already passed the same or an equivalent examination of any other statutory University.
- 19. Successful examinees shall, on payment of the prescribed fees, will receive a degree in the prescribed form signed by the Vice-Chancellor.
- 20. The provisions made under the Ordinance in respect of Examination leading to the degree of Master of Mass Communication i.e. Ordinance No. 23 of 2004, shall stands repealed.

- 1) This Ordinance may be called, of "Examinations leading to the Degree of Bachelor of Arts in Social Work (वाड़:मय स्नातक समाजकार्य) Ordinance, 2015".
- 2) This Ordinance shall come into force from the date of its approval by the Management Council.
- 3) The Examinations leading to the Degree of (वाड्:मय स्नातक समाजकार्य) Bachelor of Arts in Social Work shall be in the three parts. viz. Part-I called the (वाड्:मय स्नातक समाजकार्य भाग-१) B.A. in Social Work Part-I Examination to be held at the end of the first year, Part-II (वाड्:मय स्नातक समाजकार्य भाग-२) B.A. in Social Work Part-II Examination to be held at the end of the second year and Part-III called the (वाड्:मय स्नातक समाजकार्य अंत्य ) B.A. in Social Work Final Examination to be held at the end of the third year.
- 4) The examination for each part shall be held twice a year at such places and on such dates as may be appointed by the Board of Examinations.
- 5) Subject to his compliance with the provisions of this Ordinance and of other Ordinances in force from time to time, an applicant for admission to the (वाड्:मय स्नातक समाजकार्य भाग-१) B.A. in Social Work Part-I Examination.
  - (i) Shall have passed not less than one academic year previously
    - (a) The XII Standard Examination of Maharashtra State Board of Secondary & Higher Secondary Education; or the XII Standard Examination of Maharashtra State Board of Secondary and Higher Secondary Education, in Vocational Stream with one Language only; or an examination recognized as equivalent thereto, with English as one of the subjects of passing and with such standards of attainments as may be prescribed; or
    - (b) The examination for Certificate in Social Work of the University; and
  - (ii) Shall have prosecuted a regular course of study in a College or a recognized institution for less than

one academic year.

- 6) An examinee unsuccessful at the intermediate Examination or the Pre- Professional Examination or the (प्रथम वाड्:मय / वाड्:मय स्नातक भाग-१) First B.A./B.A.Part-I Examination of the University shall be eligible for admission to the (वाड्:मय स्नातक समाजकार्य भाग-१) B.A. in Social Work Part-I Examination on prosecuting a regular course of study for not less than one academic year in a College or a recognized Institution.
- 7) Subject to his compliance with the provisions of this Ordinance and of other Ordinances in force from time to time, an applicant for admission to the (वाड्:मय स्नातक समाजकार्य भाग-२) B.A. in Social Work Part-II Examination:
  - a) shall have passed the (प्रथम वाङ्:मय स्नातक समाजकार्य/ वाङ्:मय स्नातक- समाजकार्य भाग-१) First B.A. in Social Work/B.A. in Social Work Part-I Examination of the University not less than one academic year before his admission to the (वाङ्:मय स्नातक समाजकार्य भाग-२) B.A. in Social Work Part-II Examination, and
  - b) shall have prosecuted a regular course of study for not less than one academic year in a College or recognized Institution.
- 8) Subject to his compliance with the provisions of this Ordinance and of other Ordinances in force from time to time, an applicant for admission to the (वाड्:मय स्नातक समाजकार्य अंत्य) B.A. in Social Work Final Examination.:-
  - (a) shall have passed the (वाङ्:मय स्नातक समाजकार्य भाग-२) B.A. in Social Work Part-II Examination of the University not less than one academic year before his admission to the (वाङ्:मय स्नातक समाजकार्य अंत्य) B.A. in Social Work Final Examination; and
  - (b) shall have prosecuted a regular course of study for not less than one Academic year in a College or recognized Institution

- 9) The fees for the examinations i.e. for B.A. in Social Work Part-I, II & III shall be as prescribed by the University from time to time.
- 10) Without prejudice to the other provisions of Ordinance No.6 relating to the Examinations in General, the provisions of Paragraphs 5,8,10,27, & 32 of said Ordinance shall apply to every Collegiate candidate.
- Every examinee for the (वाड्:मय स्नातक समाजकार्य भाग-१) B.A. in Social Work Part-I Examination shall be examined in -
  - (i) English
  - (ii) Marathi/Hindi/Supplementary English, or any one of the following Classical Languages Sanskrit, Persian, Arabic, Pali and Prakrit or Latin
  - (iii) Sociology.
  - (iv) Psychology (General and Social)
  - (v) Elements of Social Work, and
  - (vi) Field work

Provided that a student whose mother tongue is neither Marathi nor Hindi may offer Supplementary English in lieu of Marathi or Hindi.

- 12) Every Examinee for the (वाड्:मय स्नातक समाजकार्य भाग-२) B.A. in Social Work Part-II Examination shall be examined in..
  - (i) English,
  - (ii) Marathi/Hindi/Supplementary English or any one of the following classical languages. Sanskrit, Persian, Arabic, Pali and Prakrit or Latin.
  - (iii) Sociology
  - (iv) Psychology and Development and Adjustment
  - (v) Methods and Techniques of Social Work.
  - (vi) Fields of Social Work Paper-I
  - (vii) Field Work.

Provided that a student whose mother tongue is neither Marathi nor Hindi may offer Supplementary English in lieu of Marathi or Hindi.

- 13) Every examinee for (वाङ्ःमय रनातक समाजकार्य अंत्य ) B.A. in Social Work Final Examination shall be examined in:-
  - (i) Sociology
  - (ii) Indian Economics
  - (iii) Social Welfare Administration and Methods of Social Investigations.
  - (vi) Fields of Social Work, Paper-II
  - (v) Fields of Social Work, Paper-III,
  - (vi) Field Work.
  - (vii) General Viva-Voce.
- 14) The scope of the subjects shall be as indicated in the Syllabus.
- 15) In order to pass either the (वाङ्:मय स्नातक समाजकार्य भाग-१, २ किंवा अंत्य) B.A. in Social Work Part-I,Part-II or Final Examination, an examinee must obtain the minimum marks as shown in Appendices 'A', 'B' & 'C' respectively. An examinee shall obtain the minimum pass marks separately in the Theory Examination and Practical Examination, wherever prescribed.
- 16) Successful examinees securing not less than 60% marks in the aggregate prescribed for the (वाड्:मय स्नातक समाजकार्य भाग-१, २ किंवा अंत्य) B.A. in Social Work Part- I, Part-II and Final Examination taken together shall be placed in the First Division, those securing less than 60% but not less than 45% in the Second Division, and all other successful examinees in the Third Division.
- 17) A successful examinee obtaining not less than 75% of marks obtainable in a subject at the (वाड्:मय रनातक समाजकार्य भाग-१, २ किंवा अंत्य) B.A. in Social Work. Part- I, Part-II and Final Examinations shall be declared to have passed the examination with Distinction in that subject.
- The provision of Ordinance 18 of 2001, relating to an Ordinance to provide grace marks for passing and improvement of Division (Higher Class) and getting distinction in the subject and condonation of deficiency of marks in a subject in all the faculties prescribed by the Statute No.18, Ordinance 2001, and of Ordinance No. 10 relating to grant of Exemptions and Compartments shall apply to the examinations under this Ordinance.

- 19) There shall be no classification of examinees successful at the (वाड्:मय स्नातक समाजकार्य भाग- १ किंवा २) B.A. in Social Work Part-I or II Examination.
- As soon as possible after the examination, but not later than the 30th June next following, in case of the examinations held in March- April and 28th February next following in case of the examinations held in October-November , the Executive Council shall publish a list of successful examinees of the (वाङ्:मय स्नातक समाजकार्य भाग-१,२ व अंत्य) B.A. in Social Work Part-I, B.A. in Social Work .Part-II and the B.A. in Social Work Final Examinations, mentioning the Division obtained in the (वाङ्:मय स्नातक -समाजकार्य) B.A. in Social Work Examination as a whole. The names of the examinees passing the examination as a whole, in the minimum prescribed period and obtaining the prescribed number of places in the First or Second Division shall be arranged in Order of Merit as provided in the Examinations in General Ordinance No.6.
- 21) Notwithstanding anything to the contrary in this Ordinance, no person shall be admitted to this examination, if he has already passed this examination or an examination of any other Statutory University.
- 22) The Students admitted to B.S.W. Part-I and B.A. in Social Work Part-I, shall have to continue their degree level subjects for the degree of B.S.W. and B.A. in Social Work respectively. That means the students admitted to B.S.W. Part-I course shall not be eligible to take admission to B.A. in Social Work Part-II and Final course, and vice versa.
- 23) An Examinee successful at the (वाङ्:मय स्नातक समाजकार्य भाग-१ किंवा २) B.A. in Social Work Part-I or II Examination shall be entitled to receive a Certificate signed by the Registrar, and on successful at the (वाङ्:मय स्नातक समाजकार्य अंत्य) B.A. in Social Work Final Examination shall on payment of the prescribed fees be awarded a Degree in the prescribed form, signed by the Vice-Chancellor.

Examinations leading to the Degree of (समाजकार्य पारंगत) Master of Social Work (Amendment) Ordinance, 2015.

Whereas, it is expedient to amend an Ordinance in respect of "Examinations leading to the Degree of **(समाजकार्य पारंगत)** Master of Social Work i.e. Original Ordinance No. 125 for the purposes hereinafter appearing, the Management Council is hereby pleased to amend the following Ordinance.

- 1 This Ordinance may be called "Examinations leading to the Degree of (समाजकार्य पारंगत) Master of Social Work (Amendment) Ordinance, 2015".
- 2. This Ordinance shall come into force from the date of its approval by the Management Council.
- 3. In para 4 (a) (ii) of the original ordinance i.e. Ordinance No. 125 in respect of Examinations leading to the Degree of (समाजकार्य पारंगत) Master of Social Work, (hereinafter referred to as the main Ordinance) the words and sign, 'B.A. in Social Work," be added after the word, 'of' and before the word, 'B.A..'
- 4. Proviso (1) of para-4 i.e. "at least 50% seats ..... Part-I Course and proviso (2) of para-4 i.e. "the minimum pass marks ........ allotted to other unreserved categories" be substituted by the following.
  - (1) reservation of seats for admission to Master of Social Work Part-I shall be as under :
