Subject :- Continuation to the issuance effect of Direction No. 27 of 2017 which was issued in respect of Examination leading to the Degree of (भेषजी रनातक) (Bachelor of Pharmacy) (Four Year -Eight Semester Degree Course) (Credit Based Semester System) (CBSS).

Whereas, "Maharashtra Public Universities Act, 2016" (VI of 2017) (hereinafter the Act) has come into force from 1st March, 2017, And

Whereas, the Higher & Technical Education Department, Govt. of Maharashtra has directed to implement the said Act with effect from 1. March, 2017,

AND

Whereas, the resolutions made by the authorities concerned from time to time, there was an exigency to amend the Ordinance /Regulation in respect of the Examinations leading to the Degree of (भेषजी स्नातक) Bachelor of Pharmacy (Four Year – Eight Semester Degree Course) (Credit Based Semester System) making and amending the respective Regulation/Ordinance is time consuming process, the Hon'ble Vice-Chancellor has issued Direction No. 27 of 2017 for the relevant Examination,

AND

Whereas, the proviso of sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016 provides that such directions to be converted into related statutory forms within six months and failing which such directions shall be automatically lapsed,

AND

Whereas, in view of exceptional circumstances arises, it is necessary to continue the issuance effect of directions No.27of 2017 which was issued in respect of Examination leading to the Degree of (भेषजी रनातक) Bachelor of Pharmacy (Four Year Degree Coursr - Eight Semester Degree Course) (Credit Based Semester System) for avoiding the administrative complications,

Now, therefore, I Dr.M.G.Chandekar, Vice-Chancellor of Sant Gadge Baba Amravati University, in exercise of power conferred upon me, under sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016, do hereby issue the following Direction.

- 1. This Directions may be called, "Continuation to the issuance effect of Direction No.27 of 2017 which was issued in respect of Examinations leading to the Degree of भेषजी स्नातक Bachelor of Pharmacy (Four Year Degree – Eight Semester Degree Course) (Credit Based Semester System Direction No.2019)
- 2. This direction shall come into force with effect from the date of its issuance.
- 3. The issuance effect of the direction No.27 of 2017 which was issued in respect of Examination leading to the Degree of (भेषजी रनातक) Bachelor of Pharmacy) (Four Year – Eight Semester Degree Course (Credit Based Semester System) shall come into force from the date of issuance and shall remain in force till the relevant Regulation/Ordinance come into being in accordance with the provision of the Maharashtra Public University Act, 2016
