Subject: Notification regarding the Prescribed Registration Fee for the Two-Credit Course on "Research & Publication Ethics (RPE)" and the Two-Credit "One-week Orientation Course/Workshop on Ph.D. Process" under Ph.D. Course Work.

It is hereby notified that the registration fee for the following mandatory Ph.D. Course Work components shall be as under:

1. **Registration Fee:**

1.	Research & Publication Ethics (RPE) – Two Credit Course	Rs. 2,000/-
2.	One-week Orientation Course/Workshop on Ph.D. Process – Two Credit Programme	Rs. 2,000/-
Total (if both are registered simultaneously)		Rs. 4,000/-

2. **Mode of Payment:** The prescribed fee shall be paid online through the University Payment Gateway. In respect of research scholars registered at the University / Affiliated Colleges Research Centers. the course fee component prescribed under Clause 1 of this Notification shall be remitted to the University by the concerned Research Centre from the Course Work Fee (Direction No. 27/2026 Appendix-11, Sr. No. 3) collected from the research scholars, in accordance with the procedure and schedule as may be notified by the University from time to time.
3. Research scholars registered at Research Centers outside the jurisdiction of Sant Gadge Baba Amravati University or other eligible learners permitted to enroll under Direction No. 26 of 2026 shall pay the prescribed registration fee directly to the University through the University Payment Gateway at the time of registration.
4. **Nature of Fee:** The registration fee shall be non-refundable and non-transferable under any circumstances.
5. **Confirmation of Registration:** Registration for the respective course/programme shall be confirmed only after successful payment of the prescribed registration fee.
6. **Applicability:**

This Notification shall be applicable to:

- a) All Ph.D. research scholars registered in the University Teaching Departments, constituent colleges/institutions, affiliated colleges/institutions, autonomous colleges/institutions, and recognized Research Centers of Sant Gadge Baba Amravati University, Amravati.
- b) Research scholars registered at Universities, colleges, institutions, or recognized Research Centers outside the jurisdiction of Sant Gadge Baba Amravati University, who are permitted to enroll in the prescribed course/programmes under the provisions of Direction No. 26 of 2026.
- c) Other eligible learners, including postgraduate students, undergraduate students with a research orientation, faculty members, recognized research supervisors/co-supervisors, and other participants admitted to the course/programmes with the prior approval of the competent authority, in accordance with Direction No. 26 of 2026.
7. **Effective Date:** This Notification shall come into force with immediate effect from the date of its publication in the University Gazette and shall remain in force until modified or superseded by a subsequent Notification.
